APPROVAL OF MINUTES The minutes from the 10/17/2017 meeting of the ASI Board of Directors were approved as presented. ( O’Toole -m/Julian -s) There were no objections.

PUBLIC SPEAKERS

Hector Elizarrarez Advocate the support of the Resolution to Denounce Milo. The decision is obvious since in the past ASI has supported resolutions for communities which Milo attacks. This resolution proves that those resolutions were not just empty words.

Jaqueline Castaneda Thanks for allowing to speak. Obvious people need ASI support. All about exchanging ideas but when there are so many communities joining together to speak out against someone.

Karina Vilchis Look around room Milo said that women cannot work together in community. Hate speech toward women, don’t allow school to be more separated. Look around at how many people who don’t want him to here because of what he represents.

Nichole Chavez	This does not only affect our students, it also affects the community. Local schools are closing that day around CSUF. Principle and academic board have shared concerns about the safety of students.
Liz Sanchez	People outside who cannot come in should be here. Fight for the majority, don't be silent, and speak up for what you believe in. Stand up for civil rights, for what you believe in.
Kait Alcantera	Spoke to a prominent member of the college republicans and asked why they were exercising their right to speech, but they were unwilling to answer. Victim and survivor of stalking, sexual assault, abuse, and of the rape culture Milo says does not exist. She doesn't feel safe on campus. This is wrong. ASI knows this is wrong.
Cirilo Duarte	History has shown, favors white supremacy. If ASI supports diversity, why allow people to come who hate. We must fight the hate, the hate that pretends to be patriotism and a leader.
No name	CSU system raises tuition but with that raise, we students of color given false sense of protection. People on campus are scared of what will happen on campus during this event. As students we should not be afraid to go to school.
No name	A lot of people outside who feel the same, scared about the event that Milo is coming. Doesn't feel right that you are just now taking time to clear this up. Many organizations have already written to denounce Milo.
No name	Article 1 Chancellor White's CSU memorandum quote. Embrace and encourage our community/university differences including protected identities. Characteristics denouncing Milo ASI will bring creditability to support all students. Neutrality is the best option for student government.
Esteban Hamilton	For neutral position. Protect all speech, watch what we say to all sides. Should welcome both sides in their political positions, not denying things to happen. Welcome both sides but not the extremities.
No name	Remind all student groups organizations who have written and passed their own memorandums. Listed groups; all student registered groups, funded or represented by ASI. Pass resolution today.
No name	Tried look for quotes from Milo, but did not want to give him anymore time/credit. Read quote from James Joyce and promoted the Unity block party next Tuesday. Unity is better than insult and self-proclaimed trolling.
Romyna Camacho	Remaining neutral is not a choice. Milo is promoting violence.
No name	Milo is not the one causing violence. These signs that are going around campus are what can cause violence. If Milo is condemned make it more open to violence. The schools aren't getting shut down because of Milo, it's because of his opponents.
Nathan Webber	I have faith in the board to evaluate. Bad ideas cannot be addressed by violence or shutting down people we don't agree with.
Joel Miskiel	Free speech is free speech. This will really push conservative students into closet, hide who they are to keep from being reprimanded. Please remember the students you represent.
No name	Hypocritical for this body to denounce the voice of the opposing students at this school. The amount of students show that passing the resolution will separate students.

Jakel paused public speakers at 1:30 p.m. to move into the Time Certain presentations.

TIME CERTAIN	Dr. Sheryl Fontaine, Dean for the College of Humanities and Social Sciences provided a PowerPoint presentation which is an attachment to the minutes.

Highlights from Dr. Fontaine's presentation include the following:

- More first generation students than many other colleges on campus.

- High rates of minority students.
- Graduation rates are generally higher than other colleges.
- Scholarships available through college. Updated some scholarships.
- Student Success Team – led by Associate Dean Lyn Sargent. Want SST to be part of the college and not a separate entity.
- 7,500 different majors with 19 departments.
- 2 Assistant Deans, one that is shared with Student Affairs and the one funded by the college who focuses on Academic Affairs.
- First year experience – piloting a program, developed by the department. 3 one unit courses; peer mentors; 130 students going through pilot program. Integrate students into college, develop a college identity.
- Study away and study abroad programs – “Study away program” there will be a spring trip to little Saigon. Spend a week visiting community leaders and cultural centers. Study abroad, offered in college, available to any student, in any college, in any major.
  - Summer programs: Italy, London, Costa Rica, South Africa, Denmark, Cambodia
  - Cal State DC – Spring and Summer (any major can participate)
- Faculty – 500 faculty (full & part-time); research grants; college provides support for faculty research. To get tenure, faculty must do research.
- Faculty developed the first year experience program.
- MCF – miscellaneous course fee – colleges get distribution. HSS each department gets an amount, but they must follow miscellaneous course fee guidelines. Competition in college, faculty/staff can request funds; give high points for collaboration, involve students, promote values of college.
- College events – exhibit in Library, alumni from 1960's, memorabilia from Buffalo Soldiers.
- Milestones & innovations – 60<sup>th</sup> anniversary for University and HSS. Celebrating along with campus. At “Concert Under The Stars” HSS invited two faculty who were hired in 1959 to the event. Lecture series, in 3<sup>rd</sup> year, which is where the theme that embraces the whole college for the year is brought up. Theme for this year, Interdisciplinary Conversations on Alternate Facts, Evidence, Interpretations, and Reality.

## TIME CERTAIN

Dr. Morteza Rahmatian, Dean for the Mihaylo College of Business and Economics spoke about the college.

Highlights from Dr. Rahmatian's presentation include the following:

- Fourth largest college of Business in the United States. Six departments; Accounting, ISDS, Marketing, Finance, Management, and Economics.
- Thirteen centers within the college with a trademark “Centers are the bridge to the community.” Connect students to centers outside of campus. The connection of students with the community, some centers work with the community and help connect students through the events. Center for Insurance studies, brought 50 insurance service providers to campus to connect students.
- 60<sup>th</sup> anniversary for the university and MCBE's 10 year anniversary next year, because that is when they moved into the building.
- 60,000 alumni in the last 60 years, great partnership from the college providing support in the amount of \$250k year.

- Dean's passion is teaching. He is still in the classroom, "in the crowd".
- Heavily recognize and emphasize research in college because of AACSB, Accreditation relies on research. Recognize, reward and encourage research to maintain the accreditation.
- 9,700 students in the college which equates to 25% of the university. Advising center served 8,000 students last year. Served 10,500 students 1-1 at workshops.
- Tutoring center used to help 4,000 to 5,000 students, but that has dropped by half because of SI, supplementary instruction.
- Successful operation, last year added 21 new faculty. This year 8 new faculty, will be hiring another 8 for next year.

Jakel resumed Public Speakers.

- Frank D Spoke about comments from a black transgender model. Spoke that ASI should remain neutral, no matter what.
- Brooke Paz For a class Journal, I covered the incident where professor Canin assaulted conservative students on campus. After presenting they bullied me into submission and hold silent tears. Pleading neutrality for students who have felt bullied for their views.
- No name Public announcement not trying to oppress student views. Not trying to convert conservatives into democrats. Stand up for what is right for our student population overall.
- No name Going to be a riot squad, going up against people who are trying to fight what we think is wrong, all have thoughts and own free will. Not right that one person coming, that all suffer consequences. For me it doesn't make sense, we aren't prisoners this is an educational setting.
- No name You cannot ignore the reason for security costs or violence on campus has anything to do with the College Republicans, it is a direct result of thinly veiled threats from off campus groups who oppose us. We cannot allow violent off-campus groups to dictate who can speak and who cannot.
- No name Address misinformation about Milo. The lies from campus have influenced our administrators. Dean of Students Hallie Hunt referred to Milo as an alt-right in a campus email, but has denounced alt right views. In conclusion, if passed, this resolution would be allowing a group of self-proclaimed radicals to influence our student government.
- No name As child of Korean immigrants, LGBTQ member, please do not limit which clubs, speakers, who I can support or see. If you truly want to support marginalized communities then help make CSUF Great Again.
- Amanda McGuire President of CSUF Republicans group. Working and representing Republican students, not here to be victim. Making sure that our student government is standing up for every marginalized groups, including conservatives. We have the support of administrators but we also need the support of student leaders.
- Jose Solano Have you ever questioned what democracy looks like? This is what it looks like. Not here to attack an individual, but to oppose an idea that is based on hate, radical, division and that does not represent the goals of ASI.
- No name If there is to be people who are threatening us, lets stand together to oppose terrorism. Show that as Titans we aren't scared and will stand by Freedom of Speech.

EXEC SENATE REPORTS  
HSSICC

Dania Salgado, HSSICC Chair, provided an update report on the goals, budget and activities for HSSICC. The report is an attachment to the minutes.

Bonney asked about the climate of the ICC when they passed the memorandum denouncing Milo. Salgado shared that during the group's discussion several members felt important to take a stance. There were members who weren't sure about the memorandum. Mostly supportive in taking a stance on this issue.

**a. Resolution Denouncing Milo Yiannopoulos Appearance at CSU Fullerton**

**BOD 032 17/18 (Governance)** A motion was brought to the Board from the Governance Committee to approve a Resolution Denouncing Milo Yiannopoulos appearance at CSU Fullerton.

Jakel yielded to Rodriguez to review the Governance Committee discussion. Rodriguez reviewed the resolution and the amendments from the committee. Discussed purpose of resolution. Recognize negative history, the impact the speaker has had on communities and other campuses. Rodriguez read the 2 resolves:

- "ASI officially denounces Milo's 'troll academy tour' in order to demonstrate that ASI will uphold its previous resolutions supporting marginalized communities."
- "ASI should support the peaceful Unity Block party to celebrate diversity and education hosted by SQE to celebrate empowerment."

Jakel asked if there were any questions for the Rodriguez, Jimenez or the Governance Committee. Jakel opened the floor to discussion.

Rodriguez, implied that directors feel more that the resolution should be broader with a long term impact in the future. Rodriguez made **amendment #4 to motion BOD 032 17/18 to amend the first resolve to read "that in order to demonstrate that ASI will continue to uphold its previously passed resolutions and support marginalized communities on campus, ASI shall not encourage the use of hate speech as a means for political discussions on campus."** Sheriff seconded the amendment. Rodriguez explained the amendment is proposed to make the resolution more relevant in the future. Sheriff added that it will also help going forward with the longevity of the resolution for possible future events. Torres asked for clarification on where the amended language would be added. Rodriguez clarified that the new language will take place of first resolve. Hunt asked to have the amendment read again. Rodriguez read: "Resolved, that in order to demonstrate that ASI will continue to uphold its previously passed resolutions and support marginalized communities on campus, ASI shall not encourage the use of hate speech as a means for political discussions on campus, and let it be further." Sheppard suggested instead of saying political it should say productive. The Board discussed the difference between the word political versus productive. Sheppard made **amendment #5 to amend the amendment #4 to change the word political to productive.** Bonney seconded amendment #5. The would read: **"Resolved, that in order to demonstrate that ASI will continue to uphold its previously passed resolutions and support marginalized communities on campus, ASI shall not encourage the use of hate speech as a means for productive discussions on campus."** Jakel opened the floor to discussion on the amendment to the amendment. There was no further discussion. **Amendment #4 to motion BOD 032 17/18 passed with a 15-0-2 roll call vote. Amendment #5 to motion BOD 032 17/18 passed with a 12-3-2 roll call vote.**

Rodriguez made **amendment #6 to motion BOD 032 17/18 to amend the second resolved to read, "ASI shall support events at CSU Fullerton that endorse positive celebrations of diversity, and community empowerment."** Jimenez Perez seconded amendment #6. Sheppard shared that the amendment supports ASI goals and what we stand for, and helps people further ideas. It is important to promote diversity on campus. O'Toole shared that she supports making the resolution more generalized, can apply to other events. Jakel made **amendment #7 to amend the amendment to add the word unity into the amendment.** Torres seconded amendment #7. The amendment would read: **"Resolved, ASI shall support events at CSU Fullerton that endorse positive celebrations of unity, diversity, and community empowerment."** Jakel opened the floor to discussion on the amendment. There was no further discussion. **Amendment #6 passed with a 15-0-2 roll call vote. Amendment #7 passed with a 15-0-2 roll call vote.**

Borjas made **amendment #8 to motion BOD 032 17/18 to change the title to state "A Resolution Supporting Diverse Events at Cal State Fullerton."** Torres seconded amendment #8. Borjas spoke to the first stating the title change would address events over time. Torres spoke to the second stating this change has a long lasting impact. Rodriguez questioned if the title change would reflect the second resolve. Edwards shared that the statement "diverse events" versus supporting diversity has two different meanings. Borjas made a **friendly amendment to amendment #8 to change "diverse events" to read "Diversity"**. The amendment was read with the friendly amendment, **"A resolution supporting Diversity at Cal State Fullerton."** O'Toole commented that to summarize the two resolutions, should add denouncing hate speech to the title. Jimenez Perez agreed. Dadabhoy read ASI's Mission Statement. O'Toole made **amendment #9 to amend amendment #8 to change the title to read "A Resolution Denouncing Hate speech and supporting diversity at Cal State Fullerton."** Jimenez Perez seconded amendment #9. Torres asked if the definition of hate speech is in the resolution and can the title say we do not support hate speech instead of denounce. Bonney asked what message is being sent with hate speech in title. O'Toole responded it is a broad term, and with the resolution, the Board is clearly saying we do not support hate speech. Jimenez Perez shared the definition of hate speech can be added to the resolution. Ansari shared the resolution is not just about hate speech. Bonney shared that we must define hate speech and not sure that this Board is ready to do that, the US government hasn't defined it. Torres read Webster's Dictionary definition. The Board discussed including the definition of hate speech in the resolution. Jakel reminded the Board that the discussion is just on changing the title to include "denouncing hate speech" to the title. Jakel asked if there were any other questions or discussion. There were none. **Amendment #8 to motion BOD 032 passed with a 12-3-2 roll call vote. Amendment #9 to motion BOD 032 passed with a 10-2-5 roll call vote.**

Jakel asked if there was any further discussion on the amended motion.

Moubayed explained that the fourth whereas statement had the incorrect calculation of total students enrolled stating 78% and it should be 62%.

Bonney made **amendment #10 to motion BOD 032 17/18 to strike "Whereas, the College Republicans of CSUF will be hosting the Troll Academy Tour in October of 2017, and"**. Nguyen seconded amendment #10. Bonney spoke to the first stating that this does not support the long term impact of the resolution. Jakel opened the floor to discussion. Torres asked if the goal was to strike any statements in the resolution

having to do with Milo. Bonney shared that it was just this statement. There was no further discussion. **Amendment #10 passed with a 10-2-5 roll call vote.**

**Jakel stated that the fourth whereas would be corrected to change 78% to 62% as a friendly amendment.** There were no objections.

Rodriguez made **amendment #11 to motion BOD 032 17/18 to add after the whereas that reads "CSUF is a marketplace of ideas, ASI does not condone events or rhetoric that incites violence, destruction, or physical harm, and" to add a new statement to read "Whereas, hate speech is defined by Webster's Dictionary as speech that is intended to insult, offend, or intimidate a person because of some trait, and".**

Jimenez Perez seconded amendment #11. Bonney asked for the definition of "some trait". Sheppard provided further clarification from Webster Dictionary, indicating that some trait is followed by, "race, religion, sexual orientation, national origin, or disability" in parenthesis. Jimenez Perez made a friendly amendment to add the trait definitions to the "whereas" statement. Bonney made **amendment #12 to**

**amendment #11 to include political ideologies to the definition of "some trait."**

Sheppard seconded amendment #12. Sheppard asked if it was okay to modify a definition. Rodriguez shared that the Board should not amend a definition. Borjas stated to cite a definition you cannot add to it, unless ASI cites their own definition.

Jakel suggested the Board could add a statement "as ASI understands this to mean."

Dadabhoy stated if the Board cites the dictionary they should stick with it. Vasquez shared thoughts to consider if it is more important to cite the definition or pull out components of definition. Rodriguez stated the Board should leave the definition as is, keep it simple. Sherman agreed with Rodriguez, the definition is broad and will be a benefit for the long term. There was no further discussion. **Amendment #12 to**

**motion BOD 032 failed with a 2-13-2 roll call vote.** Jakel asked if there was any further discussion on the amendment to add Webster's Dictionary definition of hate speech. Rodriguez made **amendment #13 amendment #11 to remove the expanded terms in parenthesis for "some trait."** Borjas seconded amendment #13. Dadabhoy stated that keeping the terms in the statement will help to clarify the definition.

There was no further discussion. **Amendment #13 failed with a 9-2-6 roll call vote.**

Jakel asked if there was any further discussion on amendment #11. There was no further discussion. **Amendment #11 to motion BOD 032 passed with a 15-0-2 roll call vote.**

Jakel asked if there was any further discussion on the amended motion. Bonney made **amendment #14 to strike Whereas statement reading "Milo Yiannopoulos has put students in jeopardy by publicly sharing information..."** Edwards suggested that if the Board is considering striking all whereas statements that include Milo's name, to do it as one item versus making individual amendments. Jakel asked Bonney to clarify his motion regarding what to strike. Bonney clarified amendment #14 to include striking the four "Whereas" statements referencing Milo Yiannopoulos. Nguyen seconded amendment #14. Bonney spoke to the first stating we don't want to give Milo a platform, to keep in line with neutrality, and many of the statements read as reportedly or approximate, which may not be factual or valid. Nguyen agreed with Bonney's statement. Jakel asked if there were any questions. There were none. Jakel opened the floor to discussion. Torres agreed with the amendment to reduce the attention given to Milo. He further stated the ICC has issues with the Milo citations in the form. There was no further discussion. **Amendment #14 passed with a 10-3-5 roll call vote.**

Bonney made **amendment #15 to strike the statement which reads, "Whereas, over 5,000 students and community members have signed a petition "No Alt-Right Speakers or Hate Groups at CSUF."** Sheppard seconded amendment #15. Bonney spoke to the first stating names no alt-right speakers or hate groups at CSUF could include members of campus. There was no further discussion. **Amendment #15 failed with a 5-2-10 roll call vote.**

Borjas made a motion to end the discussion. Hunt asked for the resolution to be read for clarification. Rodriguez made **amendment #16 to add the Whereas statements regarding Milo back into the resolution.** Jimenez Perez seconded amendment #16. Jakel asked Rodriguez to speak to the first. Rodriguez stated that he feels that it is important to cite the reason for drafting the resolution. Jimenez Perez concurred. Sheppard asked if the goal is to call Milo out, or to make statement that the Board supports diversity on campus. Rodriguez stated adding the statements back to the document is important to demonstrate the impact of Milo on campus. Borjas stated that if a person read with no context, the resolution with the person named does not bring any different context to the resolution. Jakel opened the floor to discussion. Sheriff stated that the Board went to the extent to define hate speech which brings context to the document. Bonney stated that the board voted to remove the statements, how does adding the statements back demonstrate support of all students. There was no further discussion. **Amendment #16 failed with a 3-9-5 roll call vote.**

Jakel asked if there was any objection to moving into a roll call vote on the amended motion. There were no objections.

**BOD 032 17/18** (Governance) MSC: 16-0-1 The motion passed.

**b. ASI Policy  
Concerning

Statement #506**

**BOD 033 17/18** (Governance) A motion was brought to the Board from the Governance Committee to approve striking ASI Policy Concerning Elections, Policy Statement #506.

Jakel yielded to Rodriguez to provide an overview of the changes discussed and approved at the Governance Committee. Rodriguez shared that is already outlined in the ASI Bylaws, so the policy is redundant.

Jakel opened the floor to discussion. There was no further discussion.

Jakel asked if there were any objections to moving into a roll call vote. There were no objections.

**BOD 033 17/18** (Governance) MSC: 16-0-0 The motion passed.

**c. Board Leadership  
Review Committee**

**BOD 034 17/18** (Julian-m/Torres-s) A motion was made and seconded to appoint Directors from the College of ECS, Education, HHD and MCBE to serve on the Board Leadership Review Committee effective immediately through May 31, 2018.

Jakel shared that according to ASI Bylaw and for transparency the Board will need to nominate and approve committee members for the Board Leadership Review Committee. Jakel opened the floor to nominations. Snyder nominated Sheriff from the College of ECS. Sheriff accepted the nomination. Hidalgo nominated himself from the College of EDU.

Bonney nominated Nguyen from the College of HHD. Nguyen accepted the nomination.

Jakel shared that there is a conflict for MCBE. He clarified that since both directors from MCBE are serving in leadership positions, a director from one of the other colleges would need to serve this term. Jakel opened the floor to nominations and shared that this is open to any director from a college that would be serving during an alternating year. He further shared that one of the directors would need to be nominated to serve as chair of the committee.

O'Toole nominated Mackenzie Sheppard from the College of Arts. Sheppard accepted the nomination.

Jakel opened the floor to discussion. There was none. Jakel asked if there were any objections to moving into a roll call vote. Edwards clarified that the vote would be for all of the directors as a group.

**BOD 034 17/18** (Julian-m/Torres-s) MSC: 16-0-0 The motion passed.

Jakel opened the floor to nominations for the Board Leadership Review Chair.

O'Toole nominated Sheppard to serve as Chair. There were no other nominations. Jakel opened the floor to discussion. There was no further discussion.

Jakel asked if there were any objections to moving into a roll call vote. There were no objections. **Mackenzie Sheppard was nominated to serve as Chair of the Board Leadership Review Committee for 2017 with a 16-0-1 roll call vote.**



Dear President Garcia, Administrators, and ASI Board of Directors:

It is my duty as the Chair of the Humanities and Social Sciences Inter-Club Council to act as an official spokesperson of the organization, representing the policies, views and opinions of the organization in its relations with the campus and community at large. In doing so, I am writing on behalf of our council to denounce the upcoming event that will be bringing Milo Yiannopoulos to our campus.

We are denouncing the event on the grounds that it is financially irresponsible and brings up multiple civility concerns for our student body. Yiannopoulos is known for his offensive rhetoric that derides and threatens marginalized communities by making anti-feminist, racist, anti-Muslim, and anti-transgender remarks. Additionally, Yiannopoulos has publically released personal information of students without their consent<sup>1</sup>, which jeopardized their safety<sup>2</sup>. Aside from the civility concerns, there are also the financial aspects to the event that will cost the campus thousands in extra security. Other CSU's that have had him as a public speaker paid upwards of \$55,000 in costs<sup>3</sup>.

As a way to uphold the views of the H&SS ICC council, we are taking this stance and denouncing this event.
