

Board Meeting Minutes November 7, 2017

CALL TO ORDER:

Nicholas Jakel, ASI Board Chair, called the meeting to order at 1:15 p.m.

O'Toole reported that Sheppard is running late to the meeting. Sheppard arrived at 1:20pm.

Gelrud reported that Borjas and Jimenez Perez are attending the NASPA Western Regional conference. Jakel added that Nguyen is also in attendance at the conference.

La reported that both Zarate and La will need to step out for a brief meeting, and will return.

Jakel reported that Stambough will need to leave around 2:45pm for the Strategic Plan Steering Committee meeting.

(Torres-m/Sherman-s) a motion was made and seconded to excuse Borjas, Jimenez Perez and Nguyen's absence due to attendance at an education conference and Stambough's early departure due to university business. There were no objections.

APPROVAL OF AGENDA

(Julian -m/Torres -s) The agenda was approved as presented. There were no objections.

APPROVAL OF MINUTES

The minutes from the 10/24/2017 meeting of the ASI Board of Directors were approved as presented. (Julian-m/Torres -s) There were no objections.

PUBLIC SPEAKERS Brittany Goss

Goss on behalf of SQE gave a recap of Unity Block Party on October 31st. The event was held from 2:00 p.m. to 8:00 p.m. and there were over 600 participants, with special guest speakers, food, and live music. The event was peaceful and all who attended had a good time. Many participants commented that they were thankful

that there was an alternative event. Students are concerned with the cost of security for the Milo event, especially with the number of police present on campus. They want to know the cost and where the funds are coming from. They are asking ASI if they have access to the information, and/or if the Board can help in getting the information released to the student community as soon as possible.

TIME CERTAIN

Darren Bush, Interim Associate Vice President of Student Affairs, Student Transitions, Admissions, Outreach, Financial Aid, provided information on important dates for enrollment, a Freshman Guide for 2017 and a Transfer Guide for 2017. The information is an attachment to the minutes.

Highlights from AVP Bush's presentation included:

- Reviewed CSUF Strategic Enrollment Management (SEM) Important Dates handout. CSUF is a highly impacted campus and enrollment space is limited, so the SEM dates and requirements are firm.
- The handout includes important dates for the 2018/19 academic year.
 - FAFSA 2018 applications opened 10/1/2017 and will have a firm closure date of 3/2/2018.
 - Spring 2018 UDT admission acceptance/intent to enroll deadline, 11/15/2017.
 - Welcome to CSUF Day, 4/14/18
 - Fall 2018 FTF admission acceptance/intent to enroll deadline, 5/1/2018. UDT admission acceptance/intent to enroll deadline, 6/2/2018.
- Reviewed the First-Time Freshman Guide and Transfer Student Guide.
- Urged the Board to help distribute the information to the student community.

Sheppard asked if the information had been posted to the collegeboard.net site or other application sites for prospective students. Bush shared that they have not posted on any external websites due to past issues, however, they will look into options.

Jakel commended AVP Bush on the great job on preparing the forms.

Sherman asked if the forms are online through CSUF's website. Bush confirmed. Sherman suggested they consider providing the material to the teams that go out to high schools and JC's to promote CSUF. Bush shared that they have recruitment staff who go out, and they have an ample supply to support additional recruitment efforts. Bush answered questions about concerns raised about the application process. He shared there are three divisions working together toward the same goal, Academic Affairs, Student Affairs and Student Financial Services. He further shared that the process of improvement will take time, however they have achieved marked improvement.

Allen, thanked AVP Bush for presenting to the Board. She shared that the Board would like to extend an invitation to return to discuss student comments, questions or concerns relating to the student enrollment management tools and resources. The Board will speak to their constituents in their colleges and bring questions back for the discussion.

Dadabhoy asked if there was a document similar to the Freshman and Transfer Student Guides that offers information about financial aid. Bush responded that they are

working toward bringing a document to fruition, and also making improvements to the Financial Aid website.

EXEC SENATE REPORT HHDICC

Aly Cane, HHDICC Chair, provided an update on the goals, budget and activities for HHDICC. The report is an attachment to the minutes.

Snyder shared the ICC speaker guest list is impressive. Ansari offered an idea to get people to participate in the ICC meetings, in response to Cane's request for ideas. Torres shared that NSM would be interested in participating in HHD week. Cane gave out email contact information.

Colin Eacobellis, IFC President, provided an update on the goals, budget and activities for IFC. The report is an attachment to the minutes.

Rodriguez commented on what a great job Eacobellis has done in his position.

Dr. Clem Guthro, Dean of the Library, provided a PowerPoint presentation, which is an attachment to the minutes.

Highlights from Dr. Guthro's presentation included:

- Introduction: New to campus; first generation student; immigrant; perpetual student (4 degrees); Very student focused
- New spaces for students in the Library
 opening next week.
- First Year Experience (FYE) program working with campus on FYE for new and transfer students; Peer mentoring program to socialize first years to the library.
- Goals:
 - Library more welcoming
 - o Inclusive and a safe space
 - Library renovations
 - Increased Study Spaces currently 1,800 seats, increase to 4,000 seats;
 - Better way finding;
 - Student Advisory Board systematic process to gather student input;
 - o Partnership with ASI and student orgs.

Sheppard asked if the library has a plan to reach out to teachers/different areas on campus to share library resource information. Guthro shared that there is a library research instruction program with close to 700 classes per year. The goal of the program is to make sure students have skills to research and how to use the library's resources.

O'Toole shared that students have been questioning why the library closure has taken so long, and asked about obstacles that have kept it closed. Guthro shared issues relating primarily to Fire Marshall requirements and changes as the cause for unexpected delays and hold-ups. Current issue is the requirement to add windows which is a huge cost, delaying the opening to sometime in 2018.

IFC

TIME CERTAIN

Jakel asked if new computers would be added to the first floor south area. Guthro responded there are no plans for computers, however additional power outlets will be provided. IT controls number of computers in library. They have added an additional 100 laptops for student use.

LOBBY CORP'S

Saba Ansari, Chief Governmental Officer, provided an update on the goals, budget and activities for Lobby Corp's. The report is an attachment to the minutes.

Jakel shared that he will be sending out a survey with 3 questions and asked each board member to complete the survey. He shared that it is vital for as many students as possible to participate in the survey.

Dadabhoy shared that she has information if anyone would like to discuss GI2025. Rodriguez asked about the frequency of the strategic planning committee meetings. Jakel shared that he attends meetings one per month. Jakel informed the Board that they can send the survey link to ICCs or students in their colleges. He further shared that getting students involved is important and input will set the bar for the next 5 years. Hunt shared the importance of the students' voice. Critical for all to fill out.

Jakel, cool opportunity for the BOD to be part of writing CSUF's Strategic Plan, which has a long-term impact.

California State University, Fullerton is consistently recognized nationally as a top public comprehensive University in the West. With more than 40,000 students, Cal State Fullerton is an in-demand choice. As a leader within the 23-campus California State University system, we offer 109 exceptional degree programs, including 55 bachelor's degrees.

Applying to CSU Fullerton is a highly competitive process. As an impacted campus, there are more qualified applicants than we are able to accommodate. As a result, all freshmen applicants (from inside and outside) our local service area must anticipate meeting higher levels of competition in the admissions review process than the minimum CSU eligibility. It is very important to be well-prepared academically and adhere to all deadlines.

Important: Because CSUF is a highly impacted campus and enrollment space is limited, all of the deadlines listed below will be strictly enforced. This means that if a deadline is missed, your admission may be rescinded. To ensure a fair process for all applicants, the Eligibility Index (EI) requirement will not be determined until after the priority application filing period ends on November 30, 2017. It will be based on the number of applications received, the competitiveness of the pool, and the number of enrollment spaces available.

FRESHMAN ADMISSION REQUIREMENTS

Apply as soon as possible. The filing period for fall admission is Oct. 1, 2017 - Nov. 30, 2017. **Apply online at calstate.edu/apply**. Check your admission status at **fullerton.edu/titanonline**

After applying, you will be assigned a CSUF email address accessible through your student portal at **my.fullerton.edu.** It is important to check your portal on a regular basis. You will receive a campus-wide ID (CWID), which you will need in all contact with the university.

Accept your admission. All freshman students who are offered admission for Fall 2018 and intend to enroll must accept the offer and register for orientation on their student portal by **May 1, 2018**. A non-refundable enrollment deposit of \$250 is required. Visit **fullerton.edu/admissions** for details.

High School Course Requirements

Complete the A-G course pattern with a grade of C- or better.

- A U.S. History and Social Science: 2 years, including 1 year of U.S. history or U.S. history and government
- B English: 4 years of college-preparatory English
- 📵 Mathematics: 3 years of algebra, geometry and intermediate algebra Common Core Integrated Math I, II, III
- **D** Laboratory Science: 2 years, including 1 year biological, 1 year physical
- E Language other than English: 2 years of the same language
- Figure 1 Visual and Performing Arts: 1 year of same course in one discipline art, dance, drama/theatre or music
- G Electives: 1 year selected from the University of California A-G list, ucop.edu/agguide

All A-G requirements must be completed by high school graduation. No makeup or other summer courses will be allowed for admission.

Senior-year grades will be verified. Students who do not receive a C- grade or better in all senior-year A-G courses may have their admission rescinded.

SAT/ACT

All freshmen must submit test scores from either the SAT of the College Board or the ACT regardless of grade point average. Please note: If the SAT or ACT test is taken more than once, we will give students the benefit of the highest overall scores received, instead of the highest scores received at an individual sitting. CSUF does not include the writing scores from either test in the computation of the eliqibility index.

CSU Eligibility Index

To calculate your eligibility index from your SAT score: multiply your GPA by 800. Add that total to your new SAT score (EBRW and Mathematics only). SAT: (GPA x 800) + SAT EBRW + SAT Mathematics = CSU Eligibility Index

To calculate your eligibility index from your ACT score: Multiply your GPA by 200 and add that total to 10 times the ACT composite score. **ACT**: **(GPA x 200) + (ACT Composite x 10) = CSU Eligibility Index**

Note: High School GPA is calculated using only the grades from A-G courses in the 10th, 11th and 12th grades.

As a transfer student, you already know the endless opportunities an education can offer, and California State University, Fullerton is ready to help you take the next step to earn a baccalaureate degree! With student-centered faculty and staff, CSUF will offer you supportive services to give you the tools and guidance needed to help you reach your full potential.

California State University, Fullerton is consistently recognized nationally as a top public comprehensive University in the West. With more than 40,000 students, Cal State Fullerton is an in-demand choice. CSUF is ranked No. 1 in enrolling community college transfer students among 4-year public institutions in California. It leads the CSU in admitting and enrolling Associate Degree for Transfer (ADT) students.

Applying to CSU Fullerton is a highly competitive process. As an impacted campus, there are more qualified applicants than we are able to accommodate. As a result, all transfer applicants (from inside and outside) our local service area must anticipate meeting higher levels of competition in the admissions review process than the minimum CSU eligibility. It is very important to be well-prepared academically and adhere to all deadlines.

Important: Because CSUF is a highly impacted campus and enrollment space is limited, all of the deadlines listed below will be strictly enforced. This means that if a deadline is missed, your admission may be rescinded. To ensure a fair process for all applicants, the Transfer GPA requirement will not be determined until after the priority application filing period ends on November 30, 2017. It will be based on the number of applications received, the competitiveness of the pool, and the number of enrollment spaces available.

TRANSFER ADMISSION REQUIREMENTS

Students must meet all of the following requirements for admission to Cal State Fullerton:

- Good academic standing at the last college or university attended
- 60 transferable semester units (90 quarter units); a maximum of 70 transferable units from a community college may be used toward completion of a degree
- A minimum of 30 semester units (45 quarter units) in CSU-approved general education coursework with grades of C- or better, selected from either the CSU General Education Breadth pattern or the IGETC (Intersegmental General Education Transfer Curriculum), including completion of the "Golden Four" below by the end of Spring for Fall, and by the end of Summer for Spring admission:
 - 1 Oral Communication
 - Written Communication
 - 3 Critical Thinking
 - Mathematics/Quantitative Reasoning



I'm very satisfied so far with ASIP's commitment to reaching these goals. (1) We hosted a week of Halloween events and it was a great way to see the campus come together. (2) Traditionally, our USP team brings a winter-themed event in December. This year it will be called the Chill Out and feature new and different activities than in previous years. (3) Our collaborations continue to increase. The first Tuesday of every month is our collaboration with TTF on their food days with our open mic/karaoke position. USP worked Titan Well and their nutritionist to provide useful information and healthier snacks at their three Midterm Madness Events, which was very successful, and they are working again with them for their All Night Study Events. One of USP's Halloween event in October was in collaboration with the TSCBOT in the courtyard and they want to work together more in the future on larger events. We also are working with the Communications Commission to make All Night Study a greater event and we are still reaching out to more groups and programs to collaborate on the giveaway night. We are very excited to present Lowriders with the Chicana and Chicano Resource Center and the African American Resource Center this Tuesday. (4) We have had strong retention at our events and find regulars most at Karaoke and Open Mic on Mondays and Tuesdays and the Thursday Films. We are planning on doing our ASIP Punch Cards again in the spring semester

and be more effective with passing them out at events. (5) My coordinators have been communicating event information to the campus through printed materials, electronically in the TSU, and social media. We are going to be working with Celine a bit more at the end of this semester to have more coverage on social media.
