

MEETING MINUTES October 23, 2018

APPROVAL OF AGENDA

(Abu-Elhaija-m/Good-s) The agenda was approved as amended to include a 1:45pm Time Certain for Dr. Dave Edwards, Executive Director Report. There were no objections.

CONSENT CALENDAR

There was one item on the Consent Calendar, i) the minutes from the 10/16/2018 meeting of the ASI Board of Directors. The item on the calendar was adopted by unanimous consent.

PUBLIC SPEAKERS

Jacob Chacko, Asian Pacific American Resource Center Coordinator, distributed handouts/flyers regarding the Asian Pacific Resource Center's 10th Anniversary event to be held on Thursday, December 6th from 5:30pm to 8:00pm in the TSU Pavilion. Free for students with ID, tickets available for others through Event Brite. Proceeds go toward scholarships for students. Promote, attend, support.

Elizabeth Bobadilla, College Career Specialist, Liaison with the College of Health and Human Development. Promotion for Grad School Prep week sessions starting next week. The event will include two week long activities, sessions and expos to help students in preparing, applying, help with financial aid, and letters of recommendation. Open to all students.

Albert Xiong, Grad Student Assistant for the LGBTQ Center shared information to promote an upcoming transgender student mixer at the center. The mixer is being held to connect students, build community, learn about resources, and engage in fun activities and discussions! The mixer welcomes all students who identify as transgender, gender non-conforming, genderqueer, or are exploring their gender identity. Xiong shared information about a potential initiative to erase transgender

identities or narrow the definition of transgender. Mixer will be held 10/29 from 12:00pm to 1:30pm.

EXECUTIVE SENATE PAC/UA

Rebecca Hesgard, Chief Campus Relations Officer on behalf of the Presidential Appointee Commission/University Affairs Commission (PAC/UA), provided an update report on the goals, budget and activities for PAC/UA. The report is an attachment to the minutes.

Pettis asked for a list of committees that still need to be filled. Hesgard shared she will follow-up.

TIME CERTAIN

Dale Merrill, Dean for the College of Arts, provided a presentation highlighting the programs, goals and budget for the College. He provided the directors with a copy of the Clayes Performing Arts Center 2018 fall events brochure.

Highlights:

- Thanked the Board for IRA funding for events held through the college.
- Upcoming events:
 - Living with Clay Grad student exhibit.
 - o Bee-luther-hatchee play event ends 10/28.
 - o Children of Eden musical opens 10/26.
- 2 initiatives:
 - A Week of Welcome held the second week of school, included engagement for transfer students and various clubs and organizations for the college.
 - Campaign, Advising Week started the week of October 22nd. Goal is to improve awareness of advising options for students through the College of Arts.

Stohs asked how many had seen the Bee-luther-hatchee play, and suggested that all attend, great story and production. Dean Merrill shared that the program was a direct result of IRA funding.

EXECUTIVE SENATE

AICC

Patricia Ho, Chair for Arts Interclub Council (AICC), provided an update report on the goals, budget and activities for AICC. The report is an attachment to the minutes.

Abu-Elhaija asked if the organization requires membership dues from their members. Ho shared that some of the clubs have membership fees. Abu-Elhaija suggested meeting to talk about how to maximize the use of their budget.

TIME CERTAIN EXECUTIVE DIRECTOR

Dr. Dave Edwards, Executive Director, provided a written report which is an attachment to the minutes.

Dr. Edwards provided an update on Titan Recreation, Titan Student Union, Administration, Children's Center, Leader and Program Development, Marketing, and Human Resources.

Financial Update, Edwards yielded to Lionel Lawrence, Director of Financial Services to review the first quarter financial report for ASI and TSC.

La Scala asked about the 51% increase for the Children's Center subsidy, and the increase from the CSU & Child Nutrition subsidy. Lawrence and Edwards shared that the variance is from budget, not the amount that actually was increased to parents. La Scala asked about the budget for children's center in regards to grants. Lawrence shared an overview of the budget.

Borjas asked when the last time student fees was reviewed. Edwards shared early 2000. Torres asked if fees are evaluated, will both TSC and ASI fees be adjusted at the same time. Edwards indicated that the fees can be evaluated and adjusted at the same time, however they are separate fees.

Pettis thanked Lawrence and Edwards for the report and for providing information that explains and clarifies the reports.

Edwards reviewed the purpose of explaining the current and expected budget considerations. Edwards further reviewed the expectations and potential impact of the minimum wage increase, cost of living adjustments, insurance/benefits increases and the lower head count, which are concerns that will be considered in the upcoming budget process. The focus for budget managers and staff will be tightening the belt, evaluating where funds have been budgeted and have not been utilized, and how to mitigate the impact to the budget.

TIME CERTAIN

Dr. Sheryl Fontaine, Dean for the College of Humanities and Social Sciences, provided a PowerPoint presentation highlighting the programs, goals, and budget for the college. The presentation is an attachment to the minutes.

Highlights for the College of Humanities and Social Sciences:

- 7,279 students, more than 29 majors/minors, 18 departments, 509 faculty, and a dedicated success team for the college.
- \$40,000 in scholarships, first-year experience course for incoming freshmen, HSS pre-doctoral scholar programs (Mellon Mays Undergrad Fellows/McNair Scholars), Research Careers, Study Abroad GE courses, Cal State DC study/internships.
- Faculty Recipients of national recognition, awards, and grants. Very engaged on campus and in the community. Very active in curricular currency and development.
- HSS lecture series Community, Identity, and Belonging
- Common values for the college: Social Justice, Global Awareness, Civic Engagement

EXECUTIVE SENATE

AICA

Elizabeth Jimenez Perez, Chair for the Association for InterCultural Awareness (AICA), provided an update report on the goals, budget and activities for AICA. The report is an attachment to the minutes.

Pinon provided a verbal overview of the finances for AICA, 3.7% of budget spent (8074); 0.7% spent for events. Overall 1.4% utilized.

Borjas asked about Social Justice Week. Jimenez Perez shared it will be March 18-21.

Linares asked about the meeting dates times and locations. Meetings are held on Thursdays from 3:00pm-5:--pm in TSU Gabrielino.

Baker asked why APAC was removed. Jimenez Perez shared that there are requirements to be part of AICA and they did not adhere to all requirements.

Aldazabal asked how can the Board support and collaborate with AICA. Jimenez Perez shared the attending the Multicultural program, attending meetings, participating in events. Pinon shared that the Board can remember that AICA is part of ASI and to continue to involve AICA in ASI conversations.

TIME CERTAIN

Sarah Bauer, Title IX Coordinator, provided a PowerPoint presentation highlighting an overview of the Title IX and Gender Equity department.

Highlights:

- Overview of Title IX law 1972
- Policy overview for the CSU and on campus
- Department tasks: Education & Training, Reports & Complaints and Prevention & Advocacy
- Sexual Assault Rates During College (research 2016) 21% women, 7% men;
 28% trans
- Reporting statistics based on CSUF survey responses
- Number of complaint reports to Title IX, the nature of reports, and demographics for complainants.
- Priorities: Hiring Deputy Title IX Coordinator, Visibility Campaign, and Training

Waymire asked about the impact of the US President's administration wanting to change the transgender definition. Bauer indicated that the proposed initiative may not impact campus too much, since the CSU has its own definition for all campuses.

Quinones asked if there is an explanation as to why the number of reports is increasing. Bauer shared several factors including increased training as having an impact on the number of reports.

Baker asked what percent of the reports/incidents are from the housing area. Bauer reported that 10-12% are reports from housing.

Oseguera shared the Bauer and Title IX reports directly to her office. She thanked Bauer and the Title IX team for their hard work. She encouraged the Board to pay attention to training that is required, know how to intervene, how to refer, and how to support. Being good citizens is critical and if you see something, say something.

Bauer shred that the Title IX office accepts anonymous reports. Policy has a safeguard to not pursue someone making a report who may have other issues needing to be addressed.

Aldazabal, asked how Title IX and ASI support trans students affected by the Trump administration memo. Bauer shared the office will be working with the Resource Center to provide additional support.







CSU's Definition of Gender as of 10-5-16

- Sex includes pregnancy, childbirth, breastfeeding or any related medical conditions
- Gender Identity means a person's identification as male, female, a gender different from the person's sex at birth or transgender
- Gender Expression means a person's gender-related appearance or behavior whether or not stereotypically associated with the person's assigned sex at birth.
- **Transgender** is a general term that refers to a person whose gender identity differs from the person's sex at birth. A transgender person may or may not have a gender expression that is different from the social expectation of the sex assigned at birth. A transgender person may or may not identify as transsexual.
- **Sex Stereotyping** means an assumption about a person's appearance or behavior or about an individual's ability or inability to perform certain kinds of work based on a myth, social expectation, or generalization about the individual's sex.






