
11. Announcements/Member's Privilege

The most important involvements I have had on campus include my time in the ASI Academic Senate, Pilipinx–American Student Association (PASA), the Nursing Student Association and the College of HHD Peer Mentoring program. I have also had years of volunteer experience at local hospitals and office experience as an office assistant.

As a student representative in ASI, I had the opportunity to be a member of the search committee for the AVP for Research and Sponsored Projects. This was the most interaction I had with such a diverse collection of faculty members in my entire college career, and it made me realize just how much goes on behind the scenes. I think this provides experience to almost enhance teacher–student relationships, and what I learned in my time as a student representative was how much our teacher–scholar model is a vital component on our campus. I would love to continue to promote that academic cornerstone as a part of CEC.

In PASA, diversity and inclusion are among the most important notions in our organization. The largest events we hold, like Friendship Games, and our peer mentoring program, called AKA, have put me in the position to continuously look for ways to reach out and meet other students. Being in a cultural organization has led me to meet students not only from my college community, but also those who are of different colleges. In any leadership position, it is vital to recognize and understand the ideas of students of different paths. In order to be successful in the Community Engagement Commission, upholding the importance of diversity and inclusion is essential.

My time in the Nursing Student Association has allowed me to meet with students within the College of HHD, as they all hold interest in a common career path – nursing. I have been able to learn of the plans and vastness of goals that other students around me have, and has left me inspired and forever grateful to be a part of such a great academic program that is CSUF's School of Nursing. I will also add that I have been voted and elected as a board member, Activities Director, for the upcoming school year. I attribute my success in my election to my ideas for improving interclub AND intraclub relations, as well as my active involvement in our organization. our community.

While this is more of an academic position, I have found that communication and decision making are important qualities that are necessary for any leadership position. Our peer mentorship program has allowed me to improve my interpersonal skills as well as understand the many resources we have available to us on campus and outside of campus. In the pandemic we are in, I have made it a priority to check and monitor my 4 students' mental health and holistic wellbeing, in addition to their academic careers. This is an idea I would like to extend to the rest of campus and our outside community as a part of CEC. This position has also allowed me to get in touch with other students within my major, but in other years. If it were not for joining this program and being proactive within my major, I would not have been able to connect with other students in this way.

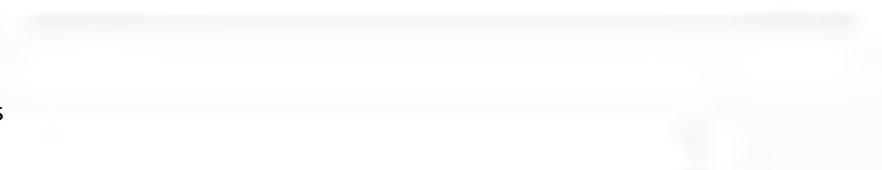

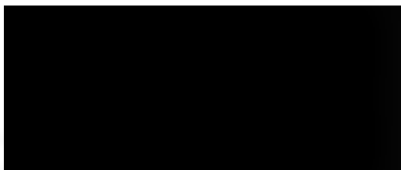

Community Engagement Commission Questions

1. In your own words, describe the purpose of the Community Engagement Commission?

The Community Engagement Commission is a mechanism for CSUF and our local Fullerton/OC community to further learn about how our communities can benefit from each other and improve. CEC provides excellent opportunities to continue to foster the relationships between students and local people across the street. Having a college-community is a unique microcosm of its own, and it is important to have a liaison like CEC to learn about ways students can integrate themselves after graduation.

2. Tell us why you think it is important to communicate the contribution of the CSUF student body to the local community?

As mentioned earlier, a liaison is necessary to continue to develop the relationship between a CSUF student and their community. College students undergo unique experiences surrounding their personal identity as a member of society, but also their responsibilities as students. Promoting ASI through CEC is a great way for the community to learn how eager students are to integrate themselves during school and even after graduation. This is also a way for students to learn about how our community impacts our school. Learning about possible local legislation and how it will affect us is a way that CEC can contribute. Our local community can also learn on how to contribute to student academic research for example.

Finally, alumni relationships and working with the Alumni house is important in CEC as many alumni are still within the area. Maintaining relationships with alumni of our school and current students can foster internship or job opportunities, or just other ways for current students to learn about the possibilities after graduation. Students of all ages and backgrounds are capable of making lasting impacts on their community - whether it be on campus, at home or just across the street.

3. Tell us about any related experience you have that you think qualifies you for or would help you be successful in the position.

My college experience has been hallmarked by organizations which promote diversity and inclusion. As an active member for the Pilipinx-American Student Association, I have been able to learn greatly about my personal culture, my culture's local community here in Orange County and I have been able to connect with a collection of students from various backgrounds - united by an appreciation for the same culture. Diversity and inclusion are key areas that our school promotes and this experience has allowed me to feel confident in promoting that as a part of CEC as well.

I have had great leadership experience as a member of the CHHD Peer Mentoring Program and a newly created student organization called the Nursing Peer Tutoring Club. These opportunities have allowed me to engage with students in my major and provide them with resources we have on campus as well as off campus. I have learned a great deal about what our school, including ASI, has to offer for its student body. In CEC, I hope to continue to learn about opportunities we have for students and see if we could extend those to our local community as well. I think that our school has the ability to lend its hand, through workshops and community house meetings, to benefit our community. My experience in these two organizations have vastly improved the way I connect with new, as well as familiar, people. I never hesitate to reach out and to schedule meetings so I can genuinely learn about ways I can help others. Being a leader requires personability, compassion and reliability - which are all skills I have gained from these organizations.

I was also a part of ASI Academic Senate / Presidential Academic Commission as a student representative on a search committee for the AVP for Research and Sponsored Projects. In this committee I had the opportunity to work with various professors, Dean Fontaine and Provost Thomas in selecting the next AVP for RSP. This opportunity showed me the benefits of having teacher-scholar relationships, not only from what we were looking for in our candidate, but also from just being able to collaborate with those who were greatly more experienced than I was. It was certainly a humbling experience, to learn from established professors in a way I hadn't before. Here I understood how much CSUF is a champion for the teacher-scholar model, and I would like to continue to facilitate that idea as a member of CEC.

I would support and promote events like park or beach cleanups are safe outdoor activities that can be completed next year, and it allows for collaboration with other commissions like the Environmental Sustainability, and even other student organizations like Fresh Air, NSA, or even social clubs - similar to the ones in which I have been involved. As a team member, as well as a board member for another organization, I believe that I would be able to promote and find students even just within my organization that would be interested.

Working with alumni liaisons and the Alumni House could be an excellent opportunity for creating panel events for students to attend, to learn about various current opportunities and events held by alumni of CSUF.

I would also like to personally attend a Fullerton city hall meeting and, if not myself, support my director or another leader in ASI to present the things that ASI is working on. This would be an excellent opportunity to provide the opportunity for student voices to be heard by local leaders in a more immediate way.

It is important as a leader to interact with their community in order to improve my interpersonal skills as well as to understand the needs of students.

I would also attend Board of Directors and Board of Trustees meetings, since those are students who represent student voices from their respective Colleges. This would allow me a great opportunity and ability to connect with students outside of my related major. In addition, these are students who were elected and voted for, so I believe that what I could learn from them would be greatly beneficial for CEC.

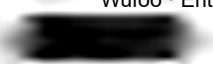

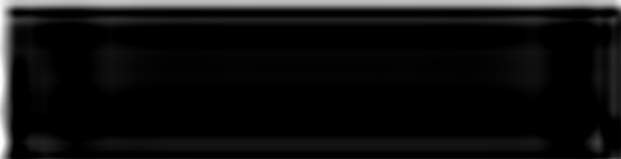

1. In your own words, describe the purpose of the Environmental Sustainability Commission?

The Environmental Sustainability Commission brings awareness to individual and organizational sustainability and advocates to implement policies and changes throughout our campus. The commission works to educate students about common actions that can be harmful to the environment and how to avoid such actions through alternative methods. Its ultimate purpose is to be the voice of sustainability on our campus.

2. Why is it important to promote environmental sustainability to students at CSUF?

While students may be already aware of the drastic effects of climate change on our environment, many do not realize how simple actions in our daily life can significantly affect climate change. Additionally, some students who understand the importance of sustainability do not know how or where to access the information. Many individuals believe that to be sustainable, they have to be a part of big projects such as planting trees, when, in reality, they can implement small changes such as using reusable or biodegradable utensils and lunchboxes.
