6. Time Certain

a. 1:45pm: Dr. Cecil Chik, AVP HRDI ~ Campus Climate Survey

Dr. Cecil Chik, AVP of HRDI, shared details on the Campus Climate Survey.

Chik said the goal of the climate survey is to inform the "Your Story, Our Story" initiative.

Chik shared details on what to expect from the results of the climate survey.

Chik emphasized they want to gauge the sense of belonging and level of inclusion felt by the campus community.

Galvan opened the floor to questions and discussion.

*Vences asked what incentives they can make for students to fill out the survey. Chik shared the possible ways to incentivize students.

*Martinez asked how they plan to market a survey of this length to the larger campus community. Chik shared the plans she has in place to market the survey. Chik also shared the methods they have already been taking as well.

*Furtado asked if the vendor doing the survey asked for personal information. Chik said any identifying information provided in the survey will not be given to her team conducting the review.

*Butorac asked if there are student groups or a student board advocating or if it is all the staff handling. Chik shared there are students involved in the various teams within the organization.

*Lieberman asked what were some concerns previously addressed by the climate survey. Chik shared the three main focuses and the recommendations and strategies recommended and implemented as a result. Community, equity, and civility. Lieberman also asked whether the Campus Climate Survey name could also be rebranded on the grounds of the word Climate being confusing. Chik recognized this as a concern and shared thoughts of how the "Your Story, Our Story" initiative will hopefully address any questions or confusion.

b. 2:15pm: Dr. Su Swarat, AVP Instructional Effectiveness & Planning

Dr. Su Swarat shared information on the Strategic Plan and the data-driven research to create it. Work on the plan will begin in the coming months. All staff and students are invited to participate in this pivotal campus event.

Galvan opened the floor to questions.

*Aquino had inquiries about the locations for the In-Person Forums. Aquino said that the location in housing is not very accessible to a large part of the population on campus. Aquino recommended utilizing the TSU or Library. Swarat shared that she would like to use more spaces that are good for community engagement, however, many have been reserved for other initiatives and events.

*Vences recommended including a map that will guide students from the TSU to the multipurpose room. Vences recommended a QR Code with a little video as well.

*Martinez shared she believes the forums are good but thinks it would be good to reach out to specific communities on campus as well in an effort to be intentional. Swarat shared there are plans in place to reach out to special interest groups and have private forums with these populations.

*Lieberman shared that the "Walk-by" Feedback options would likely have the least amount of bias. Lieberman also recommended setting up posts in various locations on campus and in front of various department buildings. Swarat asked if there are any locations he can recommend. Lieberman shared his recommendation of having them in front of college buildings or within the library.

Furtado shared some potential locations that can be used to set up posts for this as well such as the area between McCarthy Hall, Humanities and the library, in front of the TSU, and the promenade down to Langsdorf.

Butorac shared that setting up nearby the Titan letters would also be a good spot to engage students.

Castello shared information and indicated the selection of Adrian Meza to serve as ESC Director and Emeka Ogbatue as ESC Coordinator. He mentioned the impressive work Meza had done in their community.

Galvan opened the floor to questions.

Furtado asked where Meza was from and if they did any work in their hometown. Castello said he is unsure of that information and shared the information provided by Meza was impressive and that was the reason for the statement.

Galvan opened the floor to discussion. There were no points of discussion.

Galvan asked if there were any objections to moving to a roll call vote. There were no objections.

BOD 033 22/23 (Toh-Heng-m/Vences-s) Roll Call Vote: 14-0-1 The Resolution to  Appoint Adrian Meza as Director and Emeka Ogbatue as Coordinator for the Environmental Sustainability Commission has been adopted.

c. Information: CSU Tour Visit Recap

Galvan yielded the floor to Kelley, Mikaelian, Castello, Pugh, and Diaz to share details on their CSU Campus visits to Sacramento State, San Jose State, and CSU Northridge. The presentation is an attachment to the minutes.

Some of the highlights for CSUF consideration included:

- *Health Center and SRC in one location
- *Mother's Room
- *Hazard-proof drop space/receptacles around campus
- *Enhancements to Pool/Patio spaces
- *Food Pantry Enhancements
- *Oasis Wellness Center (healing, massage, nap pods, gardens, therapists)

Galvan opened the floor to questions.

*Furtado asked if there were any extensions of the Hazard-proof needle deposit containers. Kelley replied that there has been conversations around this and they have plans to expand and have them in other locations. Furtado asked if there were plans to advertise and inform students. Kelley shared that on the ASI side, they would like to work with Marketing to promote, and on a University Level, she would like to work with their marketing teams as well.

*Chammas asked what was the purpose of visiting all the campuses. Mikaelian shared they visited to take a look at the ways that other schools utilized their ASI Resources. Mikaelian

feels that in comparison the things offered by CSUF are the smaller version of those offered at other campuses.

*Kelley and Diaz also shared their points of view in regards to the point of the CSU Tour Visit Recap, and how to proceed forward given the Wellness Survey that was taken in November, and see how CSUF can better serve the wants and needs of students.

*Walsh recommended considering that CSUF is landlocked they are limited in what they can do.

*Lieberman seconded Walsh's comments and shared that he thinks they should think of ways to maximize the resources with the smallest amount of effort.

*Butorac feels the size of the resources is not the problem but more just getting visibility to the resources.

*Furtado supported Lieberman's idea of maximizing the space because they have resources but they are not exactly accessible.

*Martinez said they should look into how these campuses are getting their campus community to utilize their spaces. Mikaelian believes that they should focus on those as well, but he believes accessibility and information are issues. Mikaelian shared the student resources were all in one location and they did not have to search for them.

*Kelley mentioned the benefits of CSU Northridge with all resources in one place. *Kelley also acknowledges the accessibility problems with resources being spread across campus.

*Diaz shared that the retention rate is around 60 - 70% and the nap pods serve a few thousand students a day.

The ABC conference also gives space for Black CSU and UC students to unify and connect with one another through fellowship, discussion, and learning.

Attendees will be enriched with knowledge concerning what is required to build community and infrastructure that supports the advancement of African Americans. The objective of attending this conference is to liberate Black/African American students to feel equipped to be empowered through their post-secondary educational journey through community and understanding of structures.

The target audience for this program are a group of CSUF students who identify as Black/African American. Majority of students attending are currently in leadership roles in clubs under the BSU funding council as well as students who want to become more involved in contributing to the advancement of the campus climate and experience here at CSUF through leadership. In light of the current campus climate this semester, it is essential to provide students with the opportunity to feel seen and provided with necessary resources to navigate their educational journey at an institution where they may not feel protected from microaggressions as well as macroaggressions.

We are expecting the attendance of 34 students. This is a smaller scale event for BSU but it will have a lasting impact on those who participate. At the beginning of the school year BSU hosted Black Titan Experience which had over 200 students in attendance. The event's objective was to unify the Black community on campus and allow all students to be exposed to the various clubs under BSU council. After the event, there was an increase in participation and revival of a club (APAC) that was once inactive. Additionally, the number of applicants exceeded the amount of the anticipated number.

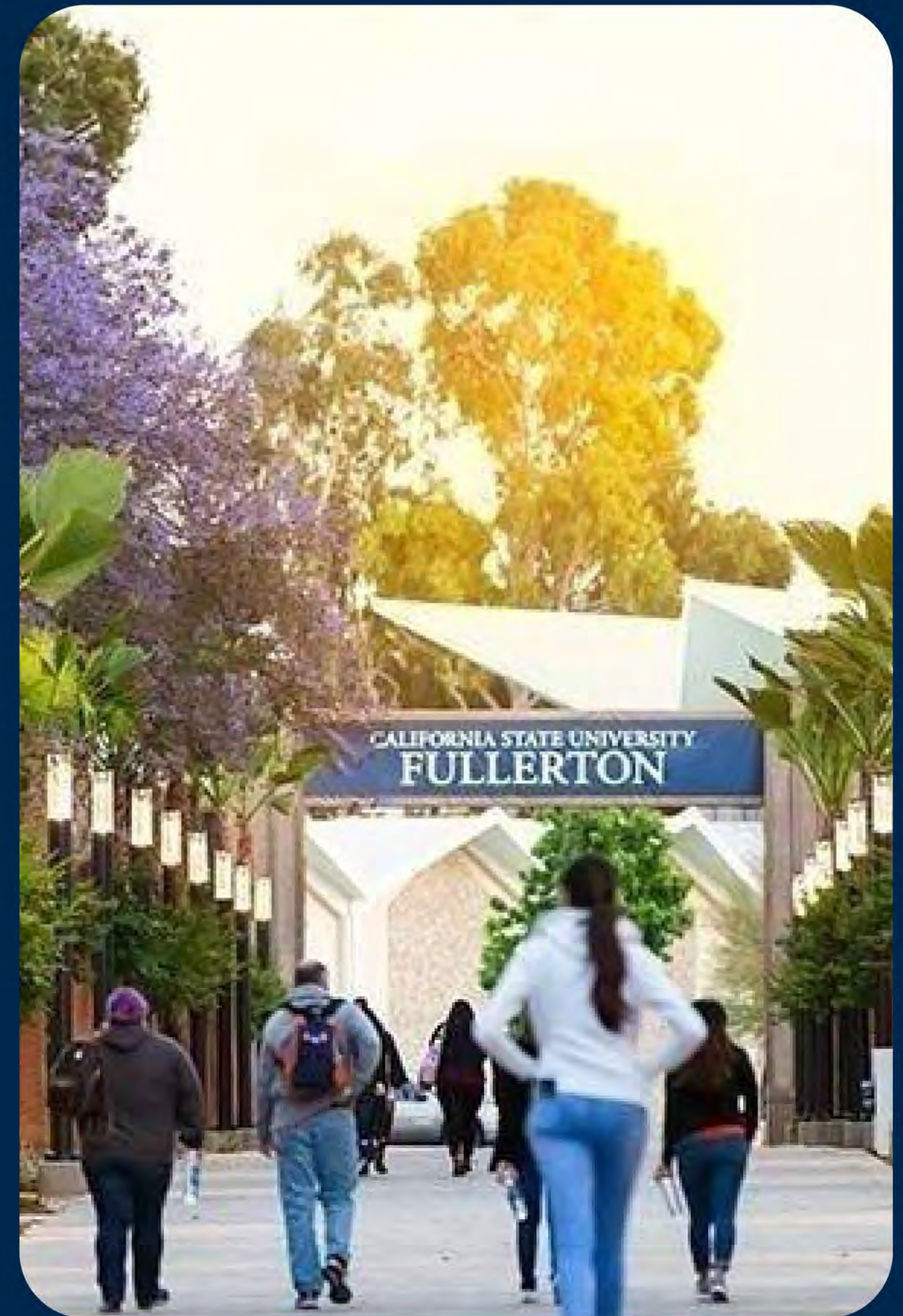

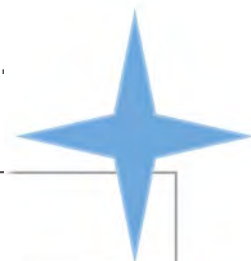

1. In your own words, describe the purpose of the Environmental Sustainability Commission?

The Environmental Sustainability Commission serves as a way for students to effectively advocate awareness on the climate crisis while serving as a voice for students' policy interests on the matter.

2. Why is it important to promote environmental sustainability to students at CSUF?
