## ASI Board of Directors Special Meeting

### 1. Call to Order ~ Awadalla, ASI President

#### 5. Public Speakers

Katie Gomez, spoke in support of Aryan as Vice Chair of the Board of Directors. Gomez highlighted Aida's interest and advocacy in Public Health and ability to reach out to different majors on that matter by sharing events and ASI's involvement in these areas.

Sarah Nishiyoka, former student of CSUF spoke in support of Aryan as Board Vice Chair. \* Zavalkov vouched for Zazueta based on her work ethic on Pan-Hellenic, and discussed the points of Wellness Initiative and her experience being points of benefit in working with the President and the Vice President on their platform.

- \* J. Morales recommended Zazueta for the position based on her willingness to help out with questions regarding BOD and the procedure of BOD while he was running for the position. J. Morales also commented on her being welcoming, and knowing her leadership and delegation skills, she would do a good job in the position.
- \* Aryan recommended Zazueta on her platform of disability in regards to the Wellness Initiative which is something Aryan agrees with in order to ensure equal access to all students.
- \* Ong supports Zazueta for the position, commenting on her initiative, friendliness, and leadership.
- \* Mansoor recommended Zazueta for the position as Greek life recruitment shows her capabilities of being a leader, and being collaborative which are good for the position.
- \* Ruelas highlighted Zazueta's combination of hard and soft skills, and discussed her as being personable, welcoming, and having a great attitude. Ruelas also admired Zazueta's disability platform and the Wellness Initiative focus and discussed the importance of student voices on this for policy and accommodations that are cohesive and direct.
- \* Amiri recommended Zazueta for the position based on Zazueta's focus in hearing out each BOD members vision and goals for the upcoming year. Amiri also discussed that from the Pan-Hellenic perspective she will be a good candidate for the position given her leadership role there.

Zazueta opened the floor to questions.

\* Zavalkov questioned Aquino's food scholarship and meal plan scholarship ideas and how the funding process would work for that. Aquino commented that the scholarship would be funded through the Wellness Initiative and through other programs on campus. Aquino added that the increase in fees would bring more money for scholarships, services, and programs, and the efficient usage of these funds would require a conversation with the Finance Committee to determine the appropriate allocations.

Zazueta yielded the floor to S. Morales to speak on her candidacy. The presentation is an attachment to the minutes.

Zazueta opened the floor to questions. There were no questions.

Zazueta opened the floor to discussion.

\* Zavalkov thanked everyone for running, and commended Furtado for his academic rigor, goals, and presentation. Zavalkov also commended Aryan's platform for the food pantry to have it up and running through its remodeling period, and her previous work experience at admissions at the university level.

\* Ramirez-Rivera vouched for Furtado and commented that Furtado, being a mentor throughout the election process, and that his initiative in reaching out, helping her out, and giving her ideas to reach out to clubs and classes were pivotal in having a graduate voice on the BOD today. For these reasons, Ramirez-Rivera recommends Furtado to the position. Ramirez-Rivera also discussed that more graduate students were voting in the previous election for her in the college, which was not common.

\* J Morales, spoke on behalf of Aryan's determination, and her ability to overcome challenges. Morales also commented that Aryan would be a great candidate to help achieve her goals while also helping others on the Board achieve theirs.

\* Brown spoke on behalf of Aryan's work, especially with her knowledge in Public Health to push things forward. Brown highlighted her tenacity, hard work, and dedication, which can be seen through her work in Association for Inter-Cultural Awareness (AICA) and increasing and helping the Black Student Union (BSU).

\* Amiri recommended Aryan for the position as she has seen Aryan's growth in the AICA Committee in the previous year as Chair and thinks she will excel in this new position.

\* Ruelas commended Aryan's work in AICA, and commended Furtado based off of previous experience as the two best candidates for the position. Ruelas also commented that from previous experience in working with Furtado, his drive and attitude showed initiative which complements his hard work and dedication for the Wellness Initiative. Ruelas also added that Furtado was able to present a lot of diverse perspectives from underrepresented populations.

\* Nguyen recommends Furtado and Aryan as both great candidates to support that would bring value to the table.

- \* Ruelas questioned whether there has been conversation regarding CAPS or DSS. Aquino commented that previously there was discussions on current facilities and how they can be improved on through the Programs & Facilities Committees, and discussion with clubs, campus organizations, and campus partners to pick what works better in accommodating students of all populations.

Zazueta opened the floor to discussion.

- \* Zavalkov commended Aquino for persevering in running for board positions, which has allowed him to better understand Aquino's platform. Zavalkov also discussed Ong's platform as resonating with that of Zavalkov and Awadalla's platform of increasing the number of therapists, and advisors, lower wait times, and expand what constitutes a crisis.
- \* J. Morales commented that a students environment constructs the experience, view, and involvement that they have with the school. Morales, J. recommends Ong for the position as someone who is passionate, caring, and advocates for all marginalized groups.
- \* Ruelas commented that the two candidates would equally provide something of benefit to the table. Ruelas discussed that for Ong, he is someone that has many layers as seen on his focus on specific DSS issues and the importance of them being vocalized, and also the perspective of an international student. For Aquino, Ruelas shared that he has previously worked with DSS, commissions and committees as Board Secretary and knows of his ability to delegate work, his perseverance, and that his advocacy for these issues does not go unnoticed.
- \* Nguyen shared with the BOD that from being a TA on Campus there has been an uptick of DSS students and shared the difficulties that exist for teaching these students. Nguyen expressed that he would like to have a discussion with the future

Board Secretary to better prepare future professors, peers, or anyone on campus for these scenarios so that people are better trained to handle these situations.

\* J. Morales spoke in favor of Ong for the position as being someone who is passionate, involved, and willing to give his all. Morales, J., also shared that Ong is personable, easy to talk to, and a people person.

\* Zavalkov commended everyone for their presentation. Zavalkov commends Ayala for his presentation and past leadership experience and thanked him for pointing out that there was a lack of representatives of the Wellness Initiative being sent to smaller organizations citing attendance and engagement difficulty as a possible reason. Zavalkov also commended J. Morales on his experience of budget management which would be relevant to the position, and his commanding presence during his presentation.

\* Aryan thanked everyone for their presentation and spoke in favor of J. Morales on his platform to promote resources to students as there are many available resources but they are not really accessible.

\* Ong thanked everyone for their presentation and spoke in favor of J. Morales given J. Morales's past experience, processes and results which are more in line with the Treasurer position in comparison to the other candidates.

\* Nguyen spoke in favor of Ayala as being helpful through the advice that he received and any ASI related information. Nguyen discussed that both Ayala and J. Morales had good fabricated skill sets, but also highlighted Ayala's work on the E-sports Lounge from scratch as the deciding factor of Nguyen's vote.

\* Seng thanked everyone for their presentation and spoke in favor of Ayala for being a good and reliable leader, and advocate which was shown during his work on the E-sports lounge.

Zazueta asked if there were any objections to moving to a roll call vote. There were no objections.

Zazueta opened the floor to points of discussion.

\* Mansoor spoke in favor of J. Morales from his experience as Vice Treasurer of the Fraternity, and shared that the year's funding went smoothly when he was in the

position.

\* Zazueta spoke in favor of J. Morales based on his inquisitive nature which is present through his openness in talking to other people by asking questions, sharing ideas, and voicing concerns, and his want to be involved.

\* Zavalkov spoke in favor of J. Morales by discussing his work as Assistant Treasurer for the Center for Autism in which J. Morales was able to create, coordinate and be involved in an event and fundraiser. Zavalkov added that this translates into not only being able to create resolutions and adopting them, but also showcases the potential for the efficiency and advocacy of creating these resolutions and standing behind them.

\* Amiri congratulated both members for the work that has been done so far, but Amiri spoke in favor of J. Morales for the position based off of previous experience as treasurer and working with money.

Zazueta asked if there were any objections to moving to a roll call vote. There were no objections.

\*Awadalla commended both on their presentation. J. Morales discussion of scholarship is in line with Awadalla and Zavalkov's idea on a scholarship hub and the Wellness Initiative, and discussed that J. Morales is good at taking in information and running on it.

\* Zavalkov discussed that he would lean towards J. Morales based off of the information presented regardless of personal experience. Zavalkov also discussed that J. Morales's platform is more in line with the board and the executive officers. Zavalkov commented that more broad scholarships will allow more people to apply for them, which is under Joe's platform of creating a scholarship hub.

Morales also shared that doing financial planning as a volunteer for a summer camp has given her experience in outside funding, different types of contracts, and with business legal studies, a better understanding of the financial parts of plans, and sales contracts. S. Morales believes her non-profit experience will serve well in this new position at ASI.



### ***California Education Code Section 89906***

No member of the governing board of an auxiliary organization shall be financially interested in any contract or other transaction entered into by the board of which he is a member, and any contract or transaction entered into in violation of this section is void.

### ***California Education Code Section 89907***

No contract or other transaction entered into by the governing board of an auxiliary organization is void under the provisions of Section 89906, nor shall any member of such board be disqualified or deemed guilty of misconduct in office under said provisions, if the circumstances specified in the following subdivisions exist:

(a) The fact of such financial interest is disclosed or known to the governing board and noted in the minutes, and the governing board thereafter authorizes, approves, or ratifies the contract or transaction in good faith by a vote sufficient for the purpose without counting the vote or votes of such financially interested member or members, and

(b) The contract or transaction is just and reasonable as to the auxiliary organization at the time it is authorized or approved.

### ***California Education Code Section 89908***

The provisions of Section 89907 shall not be applicable if the circumstances specified in any of the following subdivisions exist:

(a) The contract or transaction is between an auxiliary organization and a member of the governing board of that auxiliary organization.

(b) The contract or transaction is between an auxiliary organization and a partnership or unincorporated association of which any member of the governing board of that auxiliary organization is a partner or in which he is the owner or holder, directly or indirectly, of a proprietorship interest.

(c) The contract or transaction is between an auxiliary organization and a corporation in which any member of the governing board of that auxiliary organization is the owner or holder, directly or indirectly, of 5 percent or more of the outstanding common stock.

(d) A member of the governing board of an auxiliary organization is interested in a contract or transaction within the meaning of Section 89906, and without first disclosing such interest to the governing board at a public meeting of the board, influences or attempts to influence another member or members of the board to enter into the contract or transaction.

### ***California Education Code Section 89909***

It is unlawful for any person to utilize any information, not a matter of public record, which is received by him by reason of his membership on the governing board of an auxiliary organization, for personal pecuniary gain, regardless of whether he is or is not a member of the governing board at the time such gain is realized.

### ***California Corporations Code Section 5230***

Any duties and liabilities set forth in this article shall apply without regard to whether a director is compensated by the corporation.

***California Corporations Code Section 5231***

(a) A director shall perform the duties of a director, including duties as a member of any committee of the board upon which the director may serve, in good faith, in a manner that director believes to be in the best interests of the corporation and with such care, including reasonable inquiry, as an ordinarily prudent person in a like position would use under similar circumstances.

(b) In performing the duties of a director, a director shall be entitled to rely on information, opinions, reports or statements, including financial statements and other financial data, in each case prepared or presented by:

(1) One or more officers or employees of the corporation whom the director believes to be reliable and competent in the matters presented;

(2) Counsel, independent accountants or other persons as to matters which the director believes to be within that person's professional or expert competence; or

(3) A committee upon which the director does not serve that is composed exclusively of any or any combination of directors, persons described in paragraph (1), or persons described in paragraph (2), as to matters within the committee's designated authority, which committee the director believes to merit confidence, so long as, in any case, the director acts in good faith, after reasonable inquiry when the need therefor is indicated by the circumstances and without knowledge that would cause that reliance to be unwarranted.

***California Corporations Code Section 5233***

(a) Except as provided in subdivision (b), for the purpose of this section, a self-dealing transaction means a transaction to which the corporation is a party and in which one or more of its directors has a material financial interest and which does not meet the requirements of paragraph (1), (2), or (3) of subdivision (d). Such a director is an "interested director" for the purpose of this section.

(b) The provisions of this section do not apply to any of the following:

(1) An action of the board fixing the compensation of a director as a director or officer of the corporation.

(2) A transaction which is part of a public or charitable program of the corporation if it: (i) is approved or authorized by the corporation in good faith and without unjustified favoritism; and (ii) results in a benefit to one or more directors or their families because they are in the class of persons intended to be benefited by the public or charitable program.

(3) A transaction, of which the interested director or directors have no actual knowledge, and which does not exceed the lesser of 1 percent of the gross receipts of the corporation for the preceding fiscal year or one hundred thousand dollars (\$100,000).

**WHEREAS**, ASI is governed by ASI Board of Directors, who set policy for the organization, approve all funding allocations to programs and services, and advocate on behalf of student interests on committees and boards, and

**WHEREAS**, City National Bank is the repository for ASI's Post-Retirement Health Care and Life Insurance Employee Benefit Plan Trust, and the Children's Center Reserve account, and assets held by City National Bank are invested per ASI Policy Concerning Investments and Reserves; and

**WHEREAS**, the Associated Students Inc., CSUF Post-Retirement Health Care and Life Insurance Employee Benefit Plan, hereinafter referred to as the "Trust" was established by Declaration of Trust dated May 19, 1998; and

**WHEREAS**, the Trust provides for eligible retirees of the ASI to continue to receive medical insurance benefits in retirement similar to its active employees until such time the retiree reaches the age when they receive Medicare benefits, when ASI continues to provide a lower cost health insurance policy which is supplemental to Medicare benefits, and the purpose of the Trust is to fund post-retirement benefits from income generated from investments of assets held by the trust; and

As an LGBTQ+ male in nursing, I believe I have a unique perspective on what it feels like to not be represented in my community. I know how it feels to be different from my peers, friends and mentors, and that idea frustrated me because I seemed that I was unsupported in the issues I saw in my school and community. This led to me developing a personality that took initiative in the problems I saw around me. When I saw that my high school was suffering from a mental health decline as a result of COVID-19 and quarantine, I took it upon myself as Director of Research at my school's Mental Health Committee to create a survey that tracked the mental health of my entire school. Through the results, I found that many of my classmates were struggling with the stress of lockdown and being unable to connect with other students. I presented my findings to administration at my school and to the Temple City Unified School Board, and through these findings, I was able to push our school to acknowledge mental health as a prominent issue. I was able to push for yellow ribbon week and mental health week, where we put infographics, tables, created stalls and assemblies in order to promote self care activities and the importance of mental health. This experience has shown me that I can make change, if I take the initiative necessary. I believe this will translate directly to my role as Social Justice and Equity Commissioner, as I will need that passion and fire in order to push for equality on campus. This experience also taught me how to handle criticism and comprise, as administration from my own school were fearful of backlash from parents about the mental health surveys. In response, I had to adjust to the needs of administration, demonstrating flexibility and the ability to work with authority, which will be important as a representative of ASI. Furthermore, I believe that coming from a marginalized community has given me the perspective to empathize and better advocate for my community and other underrepresented groups. Advocacy has been a large part of my life, from my time in Planned Parenthood, Mental Health Committee and Youth Committee, and I believe that this position would allow me to further my hope in creating a better CSUF.

## Social Justice & Equity Commission Coordinator

### 1. In your own words, describe the purpose of the Social Justice and Equity Commission?

I believe that activities and events of the Social Justice and Equity Commissions would have to be promoted in a tangible way that involves a combination of physical outreach and social media presence. This is because marginalized communities on our campus most likely are not aware of ASI's main form of communication, which is through social media. Therefore, we need to physically be on campus, handing out flyers and interacting with individuals in order for them to trust us to lead campus's social justice efforts. Another way to increase outreach would be to ask professors on campus to create announcements in their classes about any activities that we may be holding. This way we can bridge that divide and reach people who normally don't go to any campus events or stay on campus after classes. Through social media, I was hoping to create a newsletter of sorts as an update about any sort of campus news or events we may be holding on a month by month basis. This would be done digitally in order to widen our scope of influence and create a recap for the month for any students willing to attend events. Like I mentioned in my previous response, having our own Instagram would go a long way in promoting engagement in our student body. We can do weekly stories, polls, surveys and posts to capture the interest of students.
