Highlights of the Presentation:

\* Awadalla discussed that Macedonio researched and prepared very well for the interview. Awadalla also discussed that Macedonio had initiative to take on the role, and was ready to work with the team. Awadalla highlighted Macedonio's experience during his time at CSUF, especially as manager of Titan Radio, which made him a perfect fit for the Chief Campus Relations Officer position and puts him in a good position to take over the Environmental Sustainability and University Affairs Commissions.

\* Macedonio thanked Awadalla, Zavalkov, Zazueta, and Hesgard for being able to present himself to the Board today. \* Furtado shared that there was a proposal for a 6% tuition fee increase in the CSU system by the Board of Trustees, and should someone want to speak on it, public comment is open on the September 12th meeting. \* Brown wanted to share that the Diversity Initiatives & Resource Centers (DIRC) which is located on the Bottom Floor of the Library, are having a LatinX Community Resource Center Welcome from 12 PM - 1 PM on September 6th, and also the Asian Pacific Resource Center Welcome on September 12th before the BOD meeting. \* Awadalla shared information regarding DiscoverFest, and some fun and games that will happen at All Day ASI. Awadalla also shared that Casey sent out surveys from training and wanted everyone to fill out the survey, and will also send a reminder in the GroupMe so that everyone fills it out.

\* Ong shared that the College of Communications is celebrating its 35th year, and in celebration of this the event CCOM 35 for 35 follows Tuffy through the different states visiting alumni, and doing activities in different locations along the way.

\* Ruelas wanted to echo DiscoverFest and All Day ASI, and encouraged sharing to clubs and organizations what it means to be a Titan. Ruelas emphasized the importance of Pride History Month in October and Hispanic Heritage month in September and just wanted to make everyone aware of this and the potential projects that can be worked upon to showcase school spirit.

\* Rivera wanted to invite everyone to an event offered by a Legal Partner on campus about Special Immigrant Juvenile Status and its Pathway to Citizenship for people who are less than 21 years of age at 12:30 PM - 1:30 PM through Zoom on the 21st of September. Rivera emphasized that this event focuses on how someone in this category can obtain citizenship, and learn about the legal services that they have available. Rivera also added that if someone else in the immediate family qualifies for this status, legal services from the university can also be used.

My name is Cameron Macedonio, and I am a fourth year communications student. Currently, I work as the General Manager of Titan Radio, CSUF's radio station. At TR, I lead a team of 12-13 people, varying per semester, and I manage a team of over 100 DJs. Leadership is not a foreign language to me, and I am comfortable being in a position where I can make difficult decisions, be diplomatic, emphasize teamwork, and create a safe environment for people to thrive. My experience at Titan Radio has been extremely beneficial, and is experience I cannot learn in a classroom or anywhere else. I have always been a leader, but being a General Manager for a radio station has really pushed my limit in the best way possible. Under my leadership, I expanded our radio programming, increased our inflow of money, increased the number of events we do, and even gained national recognition as the top 6 college radio stations in the country in multiple categories. My leadership experience from TR, nicely compliments my advocacy experience I have gained at the CSU Employees Union. The CSUEU is a labor union that non-academic workers at CSUs all across the state can be apart of, and I am working on an effort with the CSUEU to create a CSU Student Workers Union. In my work to create a CSUSWU, I have met with student workers from all across the state, virtually and in person, to learn their stories and find ways that I can help make their jobs more beneficial for them. I am an advocate at my core, and I love being able to help people get the rights that they deserve. In my work, I have spoken at rallies, statewide meetings, to local and national press, and even spoken to the CSU Board of Trustees. I was even invited to speak at a national conference this August in Boston, Massachusetts. My work is important to me, and students will always be a priority for me. My advocacy is far from performative— I have helped collect over 7,500 petitions (and counting!) to the CSU to advocate for our union, and I have also personally delivered over 600 written testimonies from students to the Chancellor's office. I am not afraid of advocating hard for students, and talking to whoever or doing whatever is necessary to ensure student happiness. I've advocated for students successfully on a statewide level, and would love the opportunity to fixate my abilities onto a much smaller environment, CSUF!

1. How would you describe the purpose and role of the University Affairs and Environmental Sustainability Commissions?

The two commissions are very influential in a student's day to day at CSUF. Through the Environmental Sustainability Commission, I would love to reward and incentivize sustainability for students. I would love to work out some sort of discounted parking pass for students with electric or hybrid vehicles, or for taking public transportation. Maybe an event where if you show us your reusable water bottle you can get a sticker that says "I reduced plastic waste!" or something similar.

One thing I would change is our presence on campus. This is the toughest, but many people don't know that the CCRO position or these Commissions exist. Finding a way to expand our reach and knowledge on campus would be a great task to accomplish, and would directly impact both the Commissions and ASI as a whole in a positive manner. Campus events can help with this, or by starting some sort of social media trend where students can tag ASI and share on their story how they were sustainable or their favorite thing about being a student at CSUF is.
