ASI Board of Directors Meeting

Tue Jan 23, 2024 1:15 PM - 3:45 PM PST

1. Call to Order

Ashley Zazueta, Chair, called the meeting to order at 1:17 pm.

2. Roll Call

5. Public Speakers

Members of the public may address Board of Directors members on any item appearing on this posted agenda or matters impacting students.

Angela Nguyen, College of the Arts undergraduate senior student, drew members' attention to the importance of the students' mental health sustainability on campus and encouraged those present to escalate the process of the Student Wellness Initiative approval.

6. Time Certain

a. 1:30pm: Dr. Sylvia Alva, CSUF President

Zazueta yielded the floor to Dr. Sylvia Alva, CSUF President, to share the recent updates.

Dr. Sylvia Alva summarized three key topics:

- 1. Upcoming Board of Trustees meetings
- 2. Conversations with the faculty
- 3. ASI Wellness Initiative

* Next week the meeting of the Board of Trustees will be held at CSULB. The key subject of discussion will be Guardian Scholars (GS). The GS initiative started in 1998 and now encompasses nearly 100 campuses across the U.S.. Dr. Alva highlighted the nationally recognized GS program at CSUF which helps students efficiently overcome financial and social barriers.

* Dr. Alva shared her enthusiasm about the preliminary agreement by the Faculty Union and CSUF. Classes and sections will be held as scheduled. Dr. Alva emphasized the importance of the recognizing faculty, coaches, librarians, and others, as well as initiatives to establish an equitable and inclusive working

environment. This includes greater access to gender-inclusive restrooms, and lactation stations. Providing an example from her personal experience, she stated that significant progress has been made in paternal leave duration increase.

* In terms of the ASI Wellness Initiative, Dr. Alva actively encouraged all members of the board to participate in the Strategic Plan launch. She expressed her appreciation for the input that has been made by the board members during the planning stage, honoring student voices. The final goal is to engage Titan pride by addressing all key needs of CSUF students which can be achieved by shifting from strategic planning to strategic doing.

* Dr. Alva further emphasized the importance of honoring student voices in the plan and expressed gratitude to the Board for their leadership. Reflecting on her early days at CSUF, she mentioned a lunch meeting with ASI leaders. The unsigned proposal, inherited from her predecessor, created division within her cabinet due to a 6% tuition increase. Faced with a decision, Dr. Alva chose to return the document, citing its deviation from the general scope. She also questioned the timing of the proposed \$1000 additional cost per semester, considering the ongoing tuition increase, and stressed the need to align proposals with referendum requirements. Despite not denying the proposal, Dr. Alva emphasized the importance of prioritizing wellness, including financial well-being, as one of the top 5 goals.

Zazueta opened the floor to questions and points of discussion.

Furtado questioned the role of Directive 10 in the decision-making process for establishing an equitable environment for students. Dr. Alva affirmed the directive's significance, detailing a comprehensive process involving research, cabinet discussions, and consultations. The central concern is the potential impact of a tuition fee increase on students.

Macedonio emphasized the University's responsibility for student wellness and expressed concerns about students carrying burdens that should be managed by administration and professionals. Dr. Alva acknowledged the importance of the Wellness Initiative and its direct benefits in alleviating mental health burdens for students. She highlighted plans to expand resources for mental health professionals and the upcoming visit of the Board of Trustees to the CSUF campus.

Ramirez-Rivera brought attention to the financial burdens on graduate students within nationally recognized Animo program. Students are burdened with paying for malpractice insurance. Dr. Alva acknowledged the issue and underscored the need for more faculty to advance the curriculum. She expressed excitement about addressing growing pains and committed to exploring solutions.

Ong's question centered on Directive 10 and the decision-making process. Dr. Alva clarified that students possess the power to reset and resubmit proposals, emphasizing transparency and the importance of students knowing what they are investing in. She explained that while she didn't outright reject the proposal, she called for a reassessment to ensure clarity.

Morales J. revisited the topic of financial burden that students face , recalling discussions from the previous spring. He inquired whether, with similar student support, Dr. Alva would sign and pass a proposal akin to the previous one. Dr. Alva responded affirmatively, stating that in the current context of tuition awareness, she would approve a reaffirmed proposal.

b. 2:00pm: Dr. Sridhar Sundaram, Dean for College of Business and Economics

Dr. Sridhar Sundaram, Dean CBE, shared general information on the college's mission and key activities.

* The purpose of the college is emphasized: changing students' lives, leading organizations, and serving communities. The vision is to be nationally recognized for the impact on students' lives and community service.

* The three key aspects of the CBE are providing the right skills (knowledge and technical skills), developing professional skills, and ensuring successful placement. The college's dual mission includes academic excellence and personal development, along with community service.

* Priorities include managing growth, improving advising services, and enhancing spaces for students.

* The college has experienced significant growth, becoming the largest at the university with a headcount of over 9,500. Demographics, including 40% first-generation students, are highlighted, influencing the need for tailored support services.

* Challenges in graduation and retention rates post-COVID are acknowledged, focusing on building a sense of community for freshmen.

* Current development projects include new spaces for Titan Capital Management, a Leadership Center, and renovated Advising Centers. Space improvements, including the new Landmark Hall, are highlighted.

* The college is actively engaging with the community through events and partnerships, contributing to economic and social development. Plans for new programs, partnerships with businesses, and emphasis on data and technology in decision-making are discussed.

Zazueta opened the floor to questions and points of discussion.

Brown expressed appreciation for the presentation and inquired about plans to increase the undergraduate black population and suggested a collaboration with the Black Business Student Association. Dr. Sridhar Sundaram acknowledged the importance of representation and discussed efforts to diversify the Advisory Board and attract diverse faculty. Plans included working with the Provost and collaborating with the director for black student success.

Macedonio appreciated the concept of Landmark Hall but raised concerns about the potential impact of removing trees in the seating areas. Dr. Sridhar Sundaram assured that efforts were made to transplant trees and create additional seating areas in the courtyard.

Ong appreciated the cultural awareness initiatives and suggested collaboration with the International Extension program. Dr. Sridhar Sundaram welcomed ideas and emphasized the importance of celebrating diverse cultures.

- * The Dean and key Directors were introduced.

- * Remaining and allocated hospitality and supplies data was shown.
- * General plans include coffee chats between students and student leaders, collaboration with BICC on spreading awareness on its events, cooperation with the Dean to deliver initiatives to encourage more transparency between students and administration.
- * General goals include enhancing a sense of transparency between students and staff, creating a bond between all students in CBE across the concentrations, and supporting student success and reputability of CBE.

i. Executive Officers Report

President, Vice President, Chief Campus Relations Officer, Chief Governmental Officer, Chief Inclusion and Diversity Officer

Awadalla, President, extended a warm welcome to the audience, expressing enthusiasm for the new semester and sharing positive experiences from the break and training sessions. The flyers were distributed for those interested in participating in the Discoverfest on January 30th and 31st. Members were encouraged to indicate their availability for tabling during the event.

Ruelas, CCO, shared updates on preparations for the semester. Notable events, including the upcoming Community Chat in February, were announced. The semester's progress was acknowledged, with plans involving the ASI Board. Ruelas also invited members to Friday office hours from 4:00 to 5:00 for those interested in discussions. Drawing inspiration from High School Musical, the emphasis was on creating lasting memories. Goals for the week included hiring two CCs to work on the end-of-year recap.

All students who worked at least one hour between May 2023 and October 2023 are eligible, even those who had graduated or are no longer employed on campus.

Ruelas shared news about MSI's Brother and Sister gathering, welcoming everyone to partake in the food and community-building resources provided. The event aims to foster a sense of community.

Dr. Edwards expressed appreciation for the meeting's success and complimented the discussions and questions. A noteworthy announcement followed, as Josh Mitchell, former ASI President and Board member generously donated funds to establish an ASI scholarship worth \$1000. It is now open for applications through the campus website, the scholarship is available to those involved in ASI, excluding executive team members or those in board leadership positions.

Jarvis informed the audience about the reinstatement of the originally scheduled Academic Senate meeting for the upcoming Thursday, with the previously tentative meeting for the following Thursday canceled.

Brown invited attendees to participate in a unique fundraising opportunity. For a nominal fee, individuals could join Brown during the general meeting on the following Thursday, offering a fun and interactive way to support the club.

Awadalla reminded everyone to sign up for Discoverfest on the 30th and 31st. Awadalla ensured a smooth process for organizing the event and encouraged the group to participate.





CBE Enrollment Trend











Figure XX: First-Time Freshmen Graduation Rates




Figure XX: Undergraduate Transfer Students Graduation Rates






Figure XX: First-Time Freshmen Retention Rate
