Gavin Ong, Chair, called the meeting to order at 2:32 pm

#### 2. Roll Call

#### 6. Reports

#### a. Chair

Starting the final Programs Assessment Committee session of the semester, Ong, Chair, expressed appreciation for everyone's hard work throughout the term and encouraged a productive discussion for the day. A reminder was given to members regarding the completion of scholarships, urging those who haven't done so to complete them promptly, even if the deadline has passed.

#### b. Director, Student Government

Hesgard, Director of Student Government, reminded attendees about upcoming events scheduled for the following week, including a beach cleanup with the University Affairs Commission, an Earth Day fair organized by the environmental sustainability group, a Children's Center book read hosted by the Community Engagement Commission, and the ASI student leader banquet. Hesgard emphasized the importance of grading scholarships promptly and encouraged participation in the upcoming activities.

#### 8. New Business

a. Discussion: SRC Services and Usage

The Committee will receive information about SRC services and usage.

Ong yielded the floor to Keith Hernandez, Operations Coordinator, to provide a report on the SRC services and Usage.

Hernandez began by outlining the mission statement of the SRC, emphasizing its goal to provide inclusive recreation opportunities for the campus community's development and well-being. Then, he discussed the methods used to achieve this mission, focusing on tracking usage through unique users and participation in programs like group fitness intervals and climbing wall activities. He highlighted the

importance of benchmarking against other campuses to assess performance and mentioned plans for future program implementations.

Gender-specific usage statistics were presented, indicating higher participation among males compared to females, with efforts being made to address this gap. Hernandez noted the impact of the pandemic on usage trends, with a gradual recovery in recent years.

Hernandez provided detailed insights into various programs offered, including group fitness classes, internal sports, and climbing wall activities. He discussed challenges with data accuracy, particularly in tracking participation in certain sports and group fitness classes.

Assessments conducted by the SRC were highlighted as crucial for gathering feedback and improving services. Hernandez shared examples of feedback received and changes implemented based on student input, such as adjusting scheduling for internal sports. Future assessment plans, including post-training surveys and parent assessments for summer camps, were mentioned. Hernandez encouraged ongoing feedback from patrons through QR code-based forms placed throughout the facility.

Ong opened the floor to questions and points of discussion.

Zavalkov inquired about the feasibility of reintroducing 11 vs. 11 soccer, a popular format from previous years. Hernandez explained that the decision to transition to 7 vs. 7 was due to logistical considerations, allowing for more teams and games.

Ramirez-Rivera raised concerns about the lower participation of female students at the SRC compared to males. Hernandez highlighted ongoing efforts to address this issue through assessments and adjustments to program scheduling, aiming to accommodate female students' preferences and increase their participation.

Rubio asked about fitness courses tailored for beginners in weightlifting. Hernandez acknowledged the previous offering of introductory weightlifting classes and expressed intentions to reintroduce them due to high demand and the need for beginner-friendly programs.

Ong inquired about the availability of classes on weekends. Hernandez confirmed that classes primarily run Monday through Friday but mentioned considerations for expanding weekend offerings in response to student housing schedules, indicating potential exploration during the summer for implementation in fall 2024.

b. Discussion: Program Assessment Recommendations The Committee will discuss potential assessment areas for the 24-25 Programs Assessment Committee.

Ong yielded the floor to Hesgard to initiate the discussion of setting up the next Programs Assessment Committee for the upcoming academic year.

Hesgard explained that the committee would assess various ASI programs to provide feedback and suggestions for improvement. Members discussed potential programs to assess, including the ASI Carnival, drop-in art workshops, Spring Concert, E-Sports Cup, and Tailgate events.

Zavalkov and Ong emphasized the need to enhance the ASI Carnival to increase participation and make it a larger, more engaging event. They also suggested extending the time for genre selection for the Spring concert to improve engagement on social media and provide more comprehensive options for selection.

The discussion expanded to include other programs like drop-in art workshops, where members proposed reducing the frequency of workshops to increase attendance and make them larger events. Mansoor also highlighted Tailgate events for potential improvement, focusing on enhancing communication, collaboration, and game selection to attract more students.

Ramirez-Rivera and Rubio emphasized the importance of raising awareness about the Food Pantry and addressing food insecurity among students through improved outreach efforts, especially for commuter students and those living in campus housing.





  - Not using effectively in Group Fitness, counts are higher than reported.






# **Creating a Culture of Assessment**

### **Current Assessments:**

- Conducted Fall 2023 Intramurals Survey
  - Sent to 943 participants
    - Included qualitative and quantitative questions
  - Received 97 responses
    - 10.2% response rate



## **Creating a Culture of Assessment**

"The schedule last semester was better because men and women played on tuesday with thursday being coed. This gave both genders the opportunity to play once each day. This semester (referring to Fall '23), since women AND coed played on thursdays, many girls had to play multiple games in one day, often spread hours apart affecting their schedule (exwomens' game at 6 and coed game at 10). This was unfair to the girls. Hoping next semester goes back to coed only on thursdays."

This feedback resulted in what we want - CHANGE:

- Women's Intramurals now on Tuesdays
- All-Rec (formerly Co-Rec) moved to Thursdays
