a. Discussion: Printing Options for the TSU Hesgard stated that Achatz would be presenting his research on possible printing options for the TSU. Hesgard yielded to Achatz.

Achatz stated he had researched two types of printers, WEPA and HP LaserJet Enterprise M806, and provided information on each. WEPA is a kiosk that has wireless printing capabilities from various electronic devices and is currently being used at UCLA and the University of Maryland. The company will install the kiosk for free as long as they receive a portion of the fees charged for printing. The HP LaserJet Enterprise M806 is the same type of printer currently being used at the CSUF Pollak Library. This printer has a huge paper and ink capacity and can print big jobs fast. One of the concerns is paper jams.

Achatz took questions from the committee regarding the wireless reach, pricing and printer specification and capabilities. Achatz agreed to continue his research and bring back more information to the committee.

Hesgard thanked Achatz for the information.

Printing Options for the Titan Student Union

WEPA



- 1. A major Kiosk option is the WEPA printer, also called Wireless Everywhere and Printing Anywhere. Currently it is used at a few universities, and students can print from their cellphones, laptops, and other wireless devices. There is currently a standard charge of 10 cents for a black and white page and 50 cents for colored page. It essentially helps to cut back on a server based system for printing.
- 2. Students can also have the option of paying by debit or credit card with only a 40 cent surcharge if they have no money on their university accounts. It is currently used at UMD and UCLA in multiple locations, and students like how easy it is to print on the go. There are over six different ways to print using WEPA such as using a printing app, a USB drive, email and just uploading through the website itself. The cost of WEPA at UCLA and UMD appears to be initially free with the company installing them.

- 3. The WEPA Company seems to provide the KIOSK printers to the University, and in return some of the income from printing fees goes to WEPA and the rest is given to ASUCLA for example, or student government corporations for managing them around campus.
- 4. University Locations: WEPA is in usage at UCLA and the University of Maryland, the Daily Bruin had very positive feedback from students using the new Kiosk printers.
