

**RESOLUTION IN SUPPORT OF INCREASING STUDENT REPRESENTATION ON
THE ADVISORY COMMITTEE TO THE TRUSTEES COMMITTEE FOR THE
SELECTION OF THE PRESIDENT**

WHEREAS, Dr. Milton A. Gordon, President of Cal State Fullerton, announced his retirement during his 22nd University Convocation on September 13th, 2011, and will remain in office until a successor has been appointed; and

WHEREAS, the Board of Trustees and the Chancellor are responsible for the “recruitment, selection, and appointment of CSU campus presidents;” and

WHEREAS, the Chair of the Board of Trustees appoints the members of the Trustees Committee for the Selection of the President (TCSP), and also appoints an advisory group to this committee, which is composed of an assortment of relevant constituent groups from the campus for which the search will be conducted; and

WHEREAS, various campus constituent groups are currently in the process of submitting names for representatives who will sit on the Advisory Committee to the Trustees Committee for the Selection of the President (ACTCSP); and

WHEREAS, the Board of Trustees Policy for the Selection of the President allows for one student representative to be submitted to the ACTCSP on behalf of the, “duly elected student representatives of the campus student body;” and

WHEREAS, in accordance with the aforementioned policy, “the Chair of the Board or the Chancellor may appoint up to two additional members from constituent groups to the ACTCSP to strengthen its capacity to cope with the complex requirements of a specific search;” and

WHEREAS, the presidential search process at Cal State Fullerton has become increasingly complex, as the university currently has five searches in progress, including a search for the Vice President of Academic Affairs and the Vice President of Student Affairs; and

WHEREAS, through a two-day campaign of spreading awareness, the Associated Students, CSUF, Inc. has acquired over 400 signatures from students who support the call for more student representation on the ACTCSP, and will continue this initiative with a goal of reaching 1,000 signatures; therefore, be it

RESOLVED, *by the ASI Board of Directors, the duly elected representatives of students at California State University, Fullerton, that the Associated Students, California State University, Fullerton, Incorporated –*

- 1) requests the appointment of additional student representatives to the ACTCSP to ensure that the student voice is represented at its full potential throughout the search process, in a time when the student perspective is more pertinent than ever; and

- 2) enters this resolution among the minutes and that copies of this resolution be distributed to the Chancellor's Office, the Chair of the CSU Board of Trustees, the University President, Offices of the Vice Presidents for Academic Affairs and Student Affairs, the Academic Senate, and to the Chairs and Directors of all ASI programs and funded/funding councils.
