**A Resolution Establishing a Student Leadership Award for Elected Student-at-Large  
Members of the Titan Student Centers Governing Board**

**WHEREAS**, The Associated Students, Incorporated (ASI) is a 501(c)(3) nonprofit organization that operates as an auxiliary organization of California State University, Fullerton; and

**WHEREAS**, ASI is governed by the ASI Board of Directors, who set policy for the organization, approve all funding allocations to programs and services, and advocate on behalf of student interests on committees and boards; and

**WHEREAS**, the ASI Executive Officers enforce the policies of the organization, implement the programs and services of the organization, and represent the organization on campus and statewide levels; and

**WHEREAS**, the Titan Student Centers Governing Board establishes policies for the Titan Student Centers to ensure the Titan Student Union, Student Recreation Center, and the Irvine lounge and fitness center are a unifying source between students, faculty, and staff; and

**WHEREAS**, the Titan Student Centers Governing Board is a sub-board of the ASI Board of Directors; and

**WHEREAS**, in the Spring of 2016 a resolution establishing a student leadership award model for ASI Student Leaders modified future distribution of financial awards; and

**WHEREAS**, that within the four levels of Student Leadership Awards, category four (4) is the Student-At-Large members: Titan Student Centers Governing Board and AICA and

**WHEREAS**, said resolution stated that Student-At-Large positions will continue to not receive a financial award, which is reflected in the organization's current practice; and

**WHEREAS**, in the Fall of 2016 the ASI Board of Directors approved the amendment of the Titan Student Centers Governing Board Bylaws to require the election of the nine (9) Student-at-Large positions as part of the annual student government elections; and

**WHEREAS**, all other elected positions within ASI receive a financial award for their time commitments to the organization and are expected to uphold the same fiduciary responsibilities; therefore let it be

**RESOLVED**, that with the adoption of this resolution, the ASI Board of Directors shall establish a financial award for Student-at-Large members on the Titan Student Centers Governing Board; and let it be

**RESOLVED**, within category four (4) there will be two groups: group one (1) will be Titan Student Centers Governing Board Student-At-Large members and group two (2) will be AICA's Student-At-Large members; and let it be

**RESOLVED**, within category four (4) group one (1) they will be compensated at 5% of average cost of attendance as determined by the CSUF Financial Aid Office; where group two (2) will continue to be not compensated; and let it be

**RESOLVED**, that the changes will be implemented for the 2017-2018 fiscal year; and let it be finally

**RESOLVED**, that this resolution be distributed to the following campus departments, divisions, and/or entities for their support and consideration: Office of the Vice President for Student Affairs, Office of the Dean of Students, ASI Executive Offices, ASI Leader & Program Development, and ASI Financial Services.
