PARENTS GUIDE TO SURUIUE CAMP

WHAT TO BRING

Summer camp is going to be a lot of fun, but it also includes long and hot days. Here is a list of things we suggest our campers bring along with them to camp:

- Sunscreen
- Swim suit, towel, and water shoes/sandals*
- Goggles
- Plastic bag for wet clothes
- Refillable Water Bottle
- Athletic clothing and shoes
- TYSC Shirt must be worn every day
- Hat and/or hair ties
- Gear (any gear campers feel they need to be comfortable in their activities)
- Extra snacks if needed
- Smile 😊

We know our campers have many hobbies outside of camp activities, but we suggest they leave their favorite items at home, like:

- Electronics*
- Cards (Yu-Gi-Oh, Pokémon, Baseball, etc.)
- Action figures/dolls
- Anything you or your camper would be sad to lose.

LUNCH & SNACKS

Full day and half day campers receive lunch and snack; Full day campers receive two snacks. The Lunch Mob is our camp caterer; menus will be available on our website under the Documents tab. We are conscious of nut allergies, we do not serve pork products and we offer vegetarian options. If you send your child with a snack, please refrain from packing products containing peanuts. Please make sure you denote any dietary restrictions when you register."

^{*}Please mark each item with your child's name. Sandals are ONLY allowed at pool time.

^{*}Campers are allowed to bring phones, however, they will only be allowed to contact parents/guardians, and only when authorized.

PARKING

A parking pass will be given to each family for the each session you have a child enrolled in camp. Parking passes will be handed out at Parent Orientations as well as on the first day of camp for each session.

PARKING OPTIONS:

- **FREE PARKING:** use the pass you are provided to drop off and pick up your camper. These passes are valid for *15 minutes* in the morning, mid-day, and in the late Afternoon.
- 30 MINUTE PARKING (FREE): turn onto Student Union Way then take your second right into the lot designated "30 minute parking."
- DAY PERMIT: parking available in lot D or the State College parking structure. Day pass is \$8.
- PAY-BY-HOUR: park in the State college parking structure and follow the signs designated "park and pay" area. \$2 per hour.

DIRECTIONS

FROM I-57 NORTH:

- 1. EXIT AT NUTWOOD AVE.
- 2. MAKE A LEFT ONTO NUTWOOD AVE.
- 3. TURN RIGHT ONTO STATE COLLEGE BLVD.
- 4. TAKE YOUR 3RD RIGHT (JUST PAST DOROTHY LN) ONTO GYMNASIUM DRIVE.
- 5. TAKE FIRST LEFT AT THE STOP SIGN.
- 6. TAKE YOUR FIRST LEFT INTO LOT D.

FROM I-57 SOUTH:

- 1. EXIT YORBA LINDA BLVD.
- 2. MAKE A RIGHT ONTO YORBA LINDA BLVD.
- 3. TURN LEFT ONTO STATE COLLEGE BLVD.
- 4. TAKE YOUR 3RD LEFT ONTO GYMNASIUM DRIVE.
- 5. TAKE FIRST LEFT AT THE STOP SIGN.
- 6. TAKE YOUR FIRST LEFT INTO LOT D.

CHECK-IN & CHECK-OUT

Checking-in your camper(s) is just as important as checking them out. Here at Titan Youth Sports Camp we want to ensure all campers are accounted for.

CHECK IN:

Regular check in begins at 8:45 am. When you arrive at the Student Recreation Center you will bring them to the back side of the SRC across from the parking lot (Parking Lot D). There will be a table where you sign in your camper(s). Doors will close at 9:00 am.

CHECK OUT:

Regular check out ends at 5:15 pm. When it is time for pick up you will go to the same place as check in, enter the basketball courts, and check your camper(s) out with their counselors.

All parents/guardians/authorized pick-ups must bring a government issued photo ID to check-out.

You will not be able to check-out your child without a valid photo ID that matches the authorized pick-up list you submitted.



LATE DROP OFF & EARLY PICK UP

Please bring your camper(s) to the front entrance of the SRC, if you are dropping them off late, and sign them in with the Front Desk Attendant. A counselor will meet you and your camper at the Front Desk.

For early pick-up please fill out a form letting our camp staff know you will be coming early with a specific time to ensure your camper doesn't miss out on any fun. Make sure to check your camper(s) out with the Front Desk Attendant and **bring your government issued form of Identification**. You will not be able to check your child out without it!

EXTENDED CARE

TYSC offers Pre and Post Care through extended hours. Pre-Care starts at 7:30 am. Post care ends at 6:30 pm.

CAMPER GROUPS

Campers will be grouped with similar age groups. For example, a group may consist of 4-5 year old campers or 5-6 year old campers. The groups depend on the amount of campers of each age we have that week. Campers may request to be with a friend or another group, however, it is depended on the amount of camper to counselors available to accommodate this request.

CAMP SCHEDULE

Activities will be rotated daily and include recreational activities, themes, and special events. A sample schedule can be found in the Documents tab. There are some events offered only in the Full day schedule including: free swim, special events, and vendors. To see a list of previous special events and vendors please reference the Documents tab."

SWIM TIME



Campers will have the opportunity to enjoy recreational swim Monday-Wednesday and Friday afternoons. They are NOT required to swim. If they cannot swim we offer a shallow water section for non-swimmers with extra supervision.

Males and females change in separate locker rooms that are closed to the public during changing time. All campers will be accompanied by at least two counselors during this time. The locker rooms do have showers, but will not be allowed for use.

Counselors will not be directly applying sunscreen during this time, so it is encouraged campers learn to apply sunscreen, or bring a spray sunscreen if they need assistance from a counselor.

STAFF CREDENTIALS

All camp staff go through an extensive application process and training before camp begins. All camp staff receive a background check and live scan before officially being hired. Camp staff are certified in First Aid and CPR. The camper to counselor ratio is 10 to 1 respectively.

MANDATED REPORTER

All youth staff receives training on recognizing the signs and symptoms of child abuse and neglect and preventing child abuse, neglect, and bullying. All youth staff are required to complete and sign the Acknowledgement of Mandated Reporter Status and Legal Duty to Report Child Abuse and Neglect which functions as a notification to each employee that he/she is a mandated reporter and that the employee knows he/she has a legal obligation to report suspected abuse or neglect to an appropriate agency such as law enforcement or the California Department of Social Services.

PARENT/GUARDIAN VISITORS

Parents and guardians are welcome to obtain a visitors pass by checking in at the Front Desk. **The visitor must have a valid form of Identification and be listed on the campers approved pickups.** We ask that you participate if you'd like, but refrain from coaching any campers.
