Highlights from Dr. Edward's report are as follows:

Welcomed everyone back from Winter break.

- Updated everyone on the Titan Recreation's over 205,000 visitors, and 10,000 people who use the drop-in fitness classes offered.
- Friday is the preferential deadline for the ASI Vice President search, this position will remain open until filled.
- AOA Conference Professional auxiliary staff conference. Allen was elected
 to the Exec Committee; Wiley was elected Chair of the sub-group for Student
 Unions; Edwards will help develop a leadership program to groom future
 Executive Directors.
- TSU Remodeling Project is in the design stage and an architectural firm will be retained to develop blueprints to remodel the upper and lower levels of the TSU
- There will be a ribbon cutting for Pieology and Hibachi San on Wednesday, February 20, 2019.
- The ASI Accounting office has been redesigned in order to bring the department staff together and to increase security.
- Update on the Children's Center; the Governance Committee visited the center and the center held holiday celebrations during Halloween and Thanksgiving.
- Reminded everyone about the ASI Scholarship applications, they open January 22nd and applications will close on March 6th.
- Open positions within ASI, these positions are posted on the ASI website for all students to apply.
- Update on the Student Government Winter retreat, there were 18-20 participants.
- Professional & Career Skill Institute held January 17th in collaboration with campus partners. Workshops will be held throughout the semester.
- The Children's Center Director search is in progress and open forums will be held for anyone to hear from the CC Director candidates.
- Marketing Coordinator position search is in the beginning stages.
- 1/25/2019 Budget Deadline for Funded & Funding Councils.
- 1/30/2019 Budget Deadline for ASI/TSC Managers.
