



A Resolution Temporarily Suspending Signature Process Due to Coronavirus Pandemic Sponsor:

WHEREAS, The Associated Students Inc., CSUF (ASI) is a 501(c)(3) nonprofit organization that operates as an auxiliary organization of California State University, Fullerton; and

WHEREAS, ASI is governed by ASI Board of Directors, sets policy for the organization, approves all funding allocations to programs and services, and advocates on behalf of student interests on committees and boards; and

WHEREAS, due to the Coronavirus pandemic, CSU Fullerton President Virjee mandated closure of Associated Students' facilities starting March 16, 2020; and

WHEREAS, this campus closure required Associated Students Inc. staff to telecommute, except essential staff; and

WHEREAS, the campus closure does not allow for students, faculty, or staff to submit hard copies of check and purchase order requests in person, as is the regular procedure; and

WHEREAS, ASI Financial Services staff continue to perform all normal review processes, therefore let it be

RESOLVED, ASI temporarily suspends the required signatures on check requests and purchase orders requests, and accepts requests via email with no signature; and let it be

RESOLVED, ASI temporarily suspends the practice of two wet ink signatures on checks over \$10,000; and let it be

RESOLVED, ASI temporarily suspends these procedures retroactive to March 16, 2020 and will continue until normal campus operations resume; and let it be finally



Hello! My name is Zachary Zirzow and I am in my first year at CSUF. I am an extremely passionate individual in every aspect of my life, and have really grown into an interest in advocacy since my junior year of high school. In high school I was a part of my city's Youth Court program, where adolescents who pled guilty to a crime would come to simulate a trial and receive their punishment in order to deter them from falling victim to a life of crime. I acted as an attorney in this activity, I would meet with the defendant for around 15 minutes and ask them questions relevant to the crime and have to present a case minutes after the conclusion of the interview. Since guilt was already admitted, the trial process was put into place to determine punishment. Through this program there was a subsection called Peer Mentorship where I was able to meet with these defendants and try to get them back on the right path. A lot of the kids had fallen victim to their upbringings, they had grown up in a crime ridden neighborhood and had no one to help them stay on track. I have never been more proud in my life than when I was able to see the positive changes the kids were making to ensure they didn't fall into a life riddled with crime. Additionally I have done numerous volunteer events with my father's disability group. After my father's serious accident that left him quadriplegic my family was in a constant search to find the best activities for him to do to maximize his well being. After he gained some movement back we were able to have him join a disability group that has arm-biking, assisted jet skiing, among numerous other activities. I have acted as an able body that helps any of the participants if they need assistance or a guide for their activity. Furthermore, I am a teacher of speech and debate for a non-profit organization called ACLA speech. I teach a debate class to children ranging from 1st to 12th grade. The aim of this organization is to introduce public speaking to students at an early age so they feel more than comfortable speaking in front of groups later in life. I have seen great improvement in the younger kids every session I work with them and truly believe they are learning incredibly valuable skills at such a young age. Since coming to CSUF I have also gotten as involved in leadership as possible. I am currently a building representative for RSA in which I advocate for changes in policy and programming for the entirety of my dormitory building. In addition I sit on the Board of Trustees as the RSA representative where it is my duty to represent housing as a whole and fight for changes that I believe the population staying in the housing community would enjoy to see. Additionally, I sit on the executive board for the housing organization NRHH in which I handle budgets, create programs, and stimulate growth in the community. Outside of organizations I am involved in I hope to attend law school after I receive my undergraduate degree, and currently have my eye on becoming a District Attorney. Going into law is something I have aspired to do for a number of years now, after my senior year I was lucky enough to intern at the Riverside District Attorney's Office under one of my mock trial coaches. This was the most informative and hands on position I could have imagined, for I went on to sit in on interviews with defendants on murder trials and authors numerous legitimate legal documents. All of these experiences have played an immense hand in formulating my aspirations to act as an advocate in as many ways as possible.

catalyzing the growth of community and overall well being of the student body. ASI goes so much more in depth than just a prototypical 'student government', they play a role in the finances of the student body, growth of the institution, and of course lobbying on behalf of the students. It is ASI's role to possess an understanding of their students' needs and take the necessary strides to satisfy each of them. I could begin to feel the profound effects of ASI when I began my journey on the Board of Trustees. I was in awe of the depth and detail the Board proceeded with and began my infatuation with joining the movement. We have so many amazing advocates spread throughout ASI spending countless hours working towards making this institution a better place. I personally am inspired by those around me and have been taking my own leaps in joining the advocacy movement. I have a true passion for advocacy and desire to attain a comprehensive understanding of the various situations our student body experiences. From differences in financial and socioeconomic upbringing to racial divides I have an extreme interest in grasping the complexity of our student body and formulating an understanding that would then allow me to advocate for every single student. I have been exposed to the difficulties that some students experience in regards to food and housing insecurity throughout my time as a student leader and that has driven me to further my place as a voice for the voiceless. Being able to cater to the differences the student body may possess from realms of education, such as learning style, to the overall campus morale, such as food insecurity, is something I wish to continue to make strides towards improving. I believe ASI is a breeding ground of opportunity for students to make a change for their community. I feel as if I will be able to feed my passion for advocacy and broaden my spectrum of understanding of our incredibly diverse student body with a position in the lobby corp. 1. In your own words, describe the purpose of the Lobby Corps Commission?

Youth Court, Riverside

August 2017- May 2019

Youth Court is an opportunity to give back to my community by participating in a small trial. This allows adolescents who plea guilty to a

crime to be put through a trial system which will result in the crime being stricken from their records. I participate as an attorney, we meet with the child who has committed the crime and have a short period to interview them. After this, we elaborate on how to present the case for around 20 minutes, then present it to a jury of former defendants directly after. It is an amazing way to deter these children from falling into a lifelong trend of crime by displaying its real life effects in a safe environment. Although no incarceration time is being offered, it still calls for a great amount of judgement and decision making on the part of the attorney. We are asked to create an entire theory of the case and present it within 20 minutes. This required us attorneys to pick and choose the pieces of evidence we feel hold the most weight and decide what punishment to suggest to the jury. As time went on, my decision making and judgement were refined greatly due to this task being placed upon me. Furthermore, once the defendant had gone through the trial process the student attorneys would have the chance to be a peer mentor. I would strive to understand the defendants' situation and give guidance in any way possible. Sometimes all the defendant needed was someone to talk to and to receive some support. Being able to be a positive guiding force to aid in restructuring a misguided peer's life was an extremely valuable experience and one I hope to continue to pursue.

1. In your own words, describe the purpose of the Environmental Sustainability Commission?

A. During the last few semesters, I noticed change throughout the food courts all over campus: most single-use plastic utensils were replaced by paper utensils. Starbucks, for example, changed their straws from plastic to paper and the plastic utensil section at the TSU food court was removed. Excited by these changes and curious as to who caused the change, I attended a meeting by the Environmental Sustainability Commission (ESC). I realized that the commission had initiated the change with the stern belief that the purpose of the ESC is to not only bring awareness about environmental sustainability and advocacy but to also implement policies and changes through campus to make it much more sustainable.

2. Why is it important to promote environmental sustainability to the students at CSUF?

A. One of the biggest threats that our generation and future generations face is climate change. Due to this, we must do our best to combat its drastic effects by implementing and incorporating sustainable means into our lifestyle. So to ensure that doesn't happen we mark their hand to see if they have already gotten the giveaway. Overall, through these experiences, I have gained variable skills and knowledge that can be useful when working with a team.

During the first semester of my sophomore year, I learned about a partnership between the Gastronome and the Arboretum, where leftover food and food waste generated by the Gastronome would be used as compost for the plants at the Arboretum. this was a fantastic partnership that reduced food waste going into landfills from our campus. When I heard that this partnership had ended, I was disappointed. One of my goals, for the upcoming year, is to see if it would be possible to rekindle this partnership. For it is extremely beneficial to the environment. Another step to a sustainable campus is to promote the little ways in which students can adopt sustainable lifestyle habits. For example, when students buy or bring their food from home, we can encourage them to bring their own utensils to reduce single-use plastic utensils. We can potentially look

into and partner with organizations to provide students with free reusable utensils. Through this, I hope to bring our campus one step closer to sustainability.

A. Social media is a powerful platform to publicize and advertise the Environmental Sustainability Commission's (ESC) events. By publishing posts ranging from flyers for the events behind the scenes of the actual events can help incorporate the public in the planning and implementation process of the events. We can also coordinate with other programming teams by having them promote the ESC's events at their events as well. Partnering with other programs or events on campus to hand out ESC's handbills during their events could help us reach a wider audience. Coordinating with the department councilors to send out mass emails advertising ESC's events can ensure that the majority of the campus population will receive an invitation. Depending on our budget, we can also incentive the campus community to attend ESC's events through the form of free shirts or gear. Ultimately, all of these strategies will help promote ESC's events to the campus community.




ASI FOOD PANTRY IMPLEMENTATION PLAN

- Location is accessible and appropriately discrete for students and also adjacent to a loading dock
- Space will be lightly renovated to suit the needs of the new pantry
