

## A RESOLUTION APPOINTING THE 2025 ASI ELECTIONS JUDICIAL COUNCIL Sponsors: Noah Alvarez

**WHEREAS**, The Associated Students, Incorporated (ASI) is a 501 (c)(3) nonprofit organization that operates as an auxiliary organization of California State University, Fullerton; and

**WHEREAS**, ASI is governed by ASI Board of Directors, sets policy for the organization, approves all funding allocations to programs and services, and advocates on behalf of student interests on committees and boards; and

**WHEREAS**, the Elections Judicial Council is established in the ASI Bylaws to hear all formal complaints pertaining to the conduct of any candidate and/or candidate team; and

**WHEREAS**, the Elections Judicial Council shall be chaired by the Elections Director and shall be comprised of the Elections Coordinators, a member of the ASI Board of Directors, and a member of the Executive Team; and

**WHEREAS**, all members of the Elections Judicial Council must have Board of Directors confirmation and declare impartiality through the elections cycle; and

**WHEREAS**, once a member is confirmed by the Board of Directors, they shall be the only voting member to represent their constituents for the duration of the elections cycle; and

**WHEREAS**, the Elections Judicial Council shall include non-voting advising support from the Director of Student Government and a campus advisor designee; therefore, be it

**RESOLVED**, DJ Giacchino, Alyssa Cova and Nathaniel Wamala are appointed to the 2025 Elections Judicial Council, given their roles as Elections Director and Elections Coordinators respectively; and be it further

**RESOLVED**, Somi Nebedum is appointed to the 2025 Elections Judicial Council as the member from the ASI Board of Directors; and be it further

**RESOLVED**, Suzette Morales is appointed to the 2025 Elections Judicial Council as the member from the Executive Team; and be it further

**RESOLVED**, Rebecca Hesgard, Director of Student Government, and Dr. Philip Vasquez, Director of Diversity, Inclusion, and Equity Programs (HRDI) shall serve as advisors to the 2025 Elections Judicial Council; and be it finally

**RESOLVED**, that this resolution be distributed to the Elections Team, Board of Directors, Executive Officers, Executive Director and applicable ASI Departments and staff.
