5. Public Speakers

 - a. 1:30 pm: Greg Pongetti, Arboretum and Botanical Garden

Greg Pongetti, Special Collections Curator for the CSUF Arboretum, shared an update on the activities, events and use of ASI funds supporting the Arboretum's operations.

Greg Pongetti, shared that the CSUF Arboretum and Botanical Garden is a self-supporting on campus. The majority of funds are raised by the Arboretum. ASI has been an important supporter. ASI fund helps support student positions which are important for operations including staffing the front entrance kiosk, and the student garden.

Funds are also raised through facility rentals facility rentals, tree sponsorships, planting fruit sales, donations, grants and memberships.

The Arboretum plans on participating in the campus-wide day of Giving in March, and raise funds for interpretive sign enhancement campaign which updates existing signs and adds more signage through the garden.

Upcoming Events and Activities:

Donations to the ASI Food Pantry. Since 2022, donations to the ASI Food Pantry have increased. About one-third of the produce harvested (2536 pounds) has been donated to the Food Pantry and 5200 pounds have been sold.

Veggie Palooza, the Spring Plant sale will take place in April and coincide with Earth Week.

Arboretum members will be invited to a hands-on rose pruning demonstration.

The Friends Terrace, a new event rental space is near completion. After the Grand Opening, the space will be available for rent.

The Arboretum has an on-going partnership with the Orange County Conservation Corps to provide students with job skills training.

experience.

The number of Arboretum interns has doubled since last semester. There are now 22 interns.

As part of a senior design project, the Arboretum is developing an interactive Children's Garden area that will include sound tubes that will allow children to step into and explore nature through the five senses.

Ong, opened the floor to questions. Brown, spoke about the possibility of taking Public Health students to the Arboretum to participate in Earth Day activities.

b. 1:45 pm: Dr. Amir Dabirian, Provost /VPAA

Dr. Amir Dabirian, Vice President of Academic Affairs/Provost, shared an update on the division of Academic Affairs. A copy of the presentation is attached to the minutes.

Provost Dabirian welcomed the students into the beginning of the 2025 Spring Semester. CSUF had the largest Fall enrollment with a student body of 43,000. In the Spring, enrollment decreases slightly to 38-39,000 students due to the number of graduations. This Spring we have 41,000 students.

CSUF just launched TitanGPT which is available to students and the Titan Community at no cost. Faculty has been encourage to embed AI into their curriculum. To support students in their usage of AI, over 200 workshops were offered last year.

Last semester, University Planner was launched as a pilot program. About twenty percent of students are now using the program. Students are encouraged to use University Planner. Usage may become mandatory in the Fall 2026.

The Academic Senate endorsed a resolution to make academic withdrawals less restrictive. The catastrophic restriction has been removed. Dr. Jarvis and the Academic Senate endorsed the resolution.

The Dreams to Degrees program was very successful and increased the graduation rate.

The IT Genius Corner makes technology accessible to all students.

Subnormal Instruction (SI) has been expanded. In collaboration with the Learning Center, SI is making sure that students can be successful in their academic mission. It has been demonstrated that students who participate in SI receive a one letter grade improvement. Students are encouraged to participate. SI is optional, and not all students who can benefit are participating in SI.

The Undergraduate Research Opportunity Center (UROC) is available for students. Students leaders are encouraged to share information with other students. The Director of Black Academic Success joined CSUF, The Director is actively working with Deans to ensure that Black students are engaged and successful in their academic journey.

The number of academic advisors has doubled. Advisors help students enrolled in the right classes. Due to improved advising, students enrolled in an average of 14 units

Student spaces have been upgraded. The first floor of Mahalo Hall is open to all students. The Black Student Academic Success Center is now in GH-223. Audio Visual upgrades are taking place throughout.

Ong opened the floor to questions

Brown asked about the percentage of withdrawals and mitigating graduation deferrals and if the number had increased since 23-24. Dabirian responded that students now have the option to self-service graduation checks.

What is being done to encourage more students to sign up to be SI leaders and increase the number of sections. Dabirian responded that faculty members are contacted to provide recommendations from the previous semester's roster.

Quock asked about adding more class options to encourage participation. Students often want to participate, but there are not enough time options available. Dabirian responded that he will look into adding more sections and diversifying the time options.

Ngo asked about the process of becoming an SI instructor. Dabirian responded that SI student candidates complete an orientation and meet with the faculty member to make sure that the instruction is aligned.

Syed asked if UROC can be a campus partner to support students with funding to help students with funding to present their research. Dabirian shared that the will share more information about summer research funding.

Dr. Jarvis shared that though the University is providing TitanGPT, that does not override the the faculty member's directives in their own class. Dabirian confirmed that the faculty member sets the standard in their own class. However, faculty are encouraged to embed AI into their curriculum and the pedagogy of the classrooms. Faculty have participated in workshops to enhance the academic experience.

Jarvis also stated that the changes on the Withdrawal Policy standardizes the process and makes it more equitable for students.

Rubio asked if faculty still has the discretion to approve withdrawals. Dabirian responded that faculty can refer to the policy when making the determination. Jarvis added that the Executive

Order requires the faculty member and their supervisor to approve the withdrawal.

Alvarez asked if faculty can ask for proof of a compelling reason. The goal is for faculty members to work with students to complete the class while following the policy. The revised policy is less restrictive than the prior one.

Ong asked how secure is TitanGPT. Dabirian stated that the campus is securing data and then purging. Student information is not being tracked.

Lopez asked if rejected withdrawals are reviewed by another faculty member. Dabirian responded that rejections can be reviewed by the Department Chair or Associate Dean.

Garibay asked if the increase of advisors were across all colleges. Dabirian responded that there were an additional 30 advisors hired and allocated across all colleges.

Syed asked if the Summer withdrawal dates can be adjusted since the summer withdrawal drop deadline is only three days after the start of the class. Dabirian responded that he will direct that students receive the withdrawal policy upon enrollment.

Rubio stated that the college of NSM sends drop date reminders via Canvas. Dabirian will ask that all colleges send the reminders.

Edwards thanked Dabirian for his years of support of the Student Leaders. Dabirian thanked the students for their dedication to elevate the student experience.

Chair Ong shared that the EJC will need one representative from the Board and one representative from the Executive Committee. According to Policy, the members must not be running for a leadership position in the coming term.

Ong yielded to Dr. Edwards. Dr. Edwards explained that this is an annual process that the Board conducts to appoint a committee to impartially review any election complaints.

Ong opened the floor to questions.

Rubio asked about the time commitment of being a part of the Committee. Edwards responded that the time commitment is typically an hour per meeting and the number of meetings depends on number of complaints.

Brown asked if any members were interested in joining the Committee. Neeki asked if the meetings would take place only on Tuesdays and Thursdays. Ong responded that the meetings are scheduled on Fridays beginning the Friday after elections. Walkley asked if the meetings were in person. Ong responded that the meetings would take place in person.

Ong opened the floor to discussion. There were no points of discussion.

Ong opened the floor to nominations.

Member Nebedum was nominated from the Board of Directors. Member Morales, S. was nominated from the Executive Committee.

The Board moved into a roll call vote.







Engineering Computer Science: The Innovation HUB project is in the design phase and expected to have the plan review check approved in May 2025






