WHEREAS, The Associated Students, Incorporated (ASI) is a 501 (c)(3) nonprofit organization that operates as an auxiliary organization of California State University, Fullerton; and

WHEREAS, ASI Board of Directors governs ASI, sets policy for the organization, approves all funding allocations to programs and services, and advocates on behalf of student interests on committees and boards; and

WHEREAS, ASI's mission is to provide students and campus community members with important social, cultural, and recreational opportunities as well as a wide range of programs and services; and

WHEREAS, ASI has historically supported student artists at Cal State Fullerton through the purchase and display of student artwork; and

WHEREAS, annually, student artists are invited to participate in art shows held in the TSU. The work is displayed in the TSU gallery during the fall and spring semesters for the campus community to review and some items are made available for purchase; and


WHEREAS, ASI may select and purchase various pieces which become part of the permanent collection of the organization; and

WHEREAS, the annual budget for acquisition and to prepare the artwork for display is \$1,000. The items selected for purchase includes Modern Day Purgatory (\$350), and Lavender Fields (\$120); therefore let it be

RESOLVED, ASI approves the proposal to purchase the selected student artwork for display in the TSU; and let it be finally

RESOLVED, that this Resolution be distributed to the ASI Executive Director, and applicable ASI departments.
