The Board will consider approving a resolution to accept the selection of ASI programs for assessment in 2025-2026.

BOD 020 25/26 (Programs Assessment) A motion was brought to the Board of Directors from the Programs Assessment Committee to approve the resolution accepting the selection of ASI programs for assessment in 2025-2026.

Chair Morales yielded to Luca Romero, Programs Assessment Committee Chair. Romero reported that the Programs Assessment Committee selected four programs for assessment in 2025-2026: the ASI Titan Youth Summer Camp, Social Justice Week, the Pantry, and the Children's Center's Nest Classroom. He explained that the summer camp was chosen because it is rarely assessed and provides important outreach to potential future Titans in the local community. Social Justice Week was selected as an opportunity to serve as a think tank for developing future programming, such as alumni or college-specific weeks. The Pantry was selected to ensure continuity following the appointment of a new coordinator, given its importance as a campus resource. Lastly, the Nest Classroom at the Children's Center was

identified as needing upgrades, with Romero noting the center's high level of use and its importance for both students and young children. He encouraged Board members to collaborate with the Committee on these assessments.

Chair Morales opened the floor to questions.

II. Academic Senate Report ~ Dr. Matt Jarvis

Chair Morales yielded to Dr. Jarvis to provide the report from the Academic Senate. Dr. Jarvis reported that no major student-related UPS policies were pending this fall, with most changes focused on faculty processes. Student-centered policies are expected in the spring. He noted the Senate's priority this year is adapting to federal policy changes while protecting the University's mission and values. Several administrative searches are underway, and he stressed the importance of appointing dependable students to serve on Committees. He added that a key goal is to make university policies resilient to external challenges.

Chair Morales opened the floor to questions.

 Chair Morales asked who was involved in the policy development process to ensure it was resilient against administrative challenges, given the range of viewpoints.

Dr. Jarvis explained that the policies would undergo the usual committee and Senate processes, with the Executive Committee ensuring compliance with

system guidelines. He noted that careful wording could make policies more resistant to challenges and emphasized that all discussions would take place publicly in Committee and Senate meetings, with faculty, students, and staff focused on protecting the intent of the policies.

 Romero inquired about the timeline for appointing student representatives to academic committees, emphasizing that their involvement was crucial for progress.

Dr. Jarvis explained that ASI had already provided students for most major search committees, including VP positions and Senate Committees, with only one or two still needing additional students. He mentioned that new searches, such as for a Dean and Associate Deans, were just beginning and that ASI would receive requests soon. He acknowledged ASI's strong support so far and encouraged students, particularly from Communications or ECS, to be ready to participate in upcoming searches.

RESOLVED, that this resolution be distributed to the ASI Executive Director and applicable ASI departments for appropriate action.
