Shared that part of her position is to oversee advocacy, and BOD representatives are needed to serve on commissions. Please reach out to participate.



## John Good - Vice Chair/Secretary Questionnaire

1. In your opinion what should be the purpose of the governance committee?
  - a. I believe the governance committee's goal should be to review and analyze past resolutions, bylaws, and policies that need to be updated. Furthermore, we should work diligently to outreach to different student organizations to identify any issues they may face and see how ASI can help assist in their experience. By actively working on student outreach and sharing that feedback at governance meetings, we can then expedite the resolution process by brainstorming specific ways we can help our students. The governance committee should be active in engaging challenging conversations by making committee members feel comfortable to present their ideologies, and more importantly work together to reach a compromise. People will always have a difference of opinion, however, through communication and open-mindedness, I believe we can share different views while working efficiently to serve our students better and help create a better working environment.
2. How will you garner student input for the changes you will propose to ASI?
  - a. Ultimately, we are here to serve students, so student input should be held in high regard regarding decision making. One way we can garner the most student input is by reaching out to student leaders of various clubs and organizations. We can do this by setting up in-person meetings, having a drop box available outside of our BOD office, and working with the executive team (more specifically Kaetlyn our CCO) to help with student outreach and ensuring active participation. Once we hear out students, it is our job to translate these concerns and issues into effective action. Whether it's drafting and passing resolutions or voting a certain way—we were elected to represent our students. We must uphold that agreement.
3. The issue of accountability of student leaders has been discussed recently. How do you think ASI should address this issue?
  - a. I believe that we should adopt a formal process that checks in with student leaders across all of ASI's entities. Whether it's by making an accountability committee with different student leaders from ASI or requesting constructive criticism from the staff that we work with—I believe we should have a “check-in” three times per semester. The initial check-in would take place at the beginning of the semester and would focus on identifying what each student leaders' goals are for the semester. The follow up meeting would happen towards the middle of the semester to see how our student leaders are doing, and if progress has been made towards achieving said goals. If progress has not been made, it is up to the committee to assign a strike to that individual. If a strike is added, that would then give the BOD authority to remove someone from their position at the end of the semester (depending on the final check-in). The last check-in would take place towards the end of the semester and used to evaluate the progress made by the specific student leader, and assess any other work that was done. If goals were not met, BOD would then have the option to remove that person or assign another strike. Strikes should carry over to the following semester because our elected positions are only one year long, and therefore as

student leaders, we need to ensure we are staying busy to get as much work done as possible in our one-year terms.

4. If you were to write a resolution that supported an increase in sustainability efforts around the CSUF campus, what are three key details that you think should be provided within the resolution? Why?
  - a. I think the first step towards writing a resolution should be to garner input from students, administration, and to research what efforts other campuses do for sustainability. After conducting research, I found three components that make “green” universities amongst the most sustainable campuses across the nation. Implementing an action plan that would result in the installation of solar panels across the campus would primarily save a ton of energy (and possibly money) for the school. The next step we need to take is working with the arboretum and children’s center to have a fully harvesting garden. The fruits and vegetables that come from our on-campus garden would then be of use inside the gastronome (and TSU Food court) for ingredients. We can also directly donate to hunger-relief organizations or students facing food insecurities. The last step we should take to increase our sustainability efforts is the creation of a sustainability center. This center’s focus would be on furthering sustainability efforts through academic engagement programs, faculty training, research, and community outreach. By applying these three details towards our resolution, CSUF would immediately be a contender for the most sustainable campus amongst CSU’s.

**Vice-Chair Secretary Q & A**

**1. In your opinion what should be the purpose of the Governance Committee?**

In my opinion, the purpose of the governance committee should be to facilitate resolution development and maintain and implement previous resolutions. Furthermore, the Governance Committee should constantly review and update ASI Policies and Bylaws. Policies and bylaws are extremely important legal documents that need to be taken seriously. Another purpose of the Governance Committee should be to make recommendations of any proposal to the Board. It is important to continue our work for the following semesters. The Governance Committee should assist the Board of Directors in operating effectively.

**2. How will you garner student input for the changes you will propose to ASI?**

I will garner student input by working closely with Tristan, so we can put together surveys and send them out. Student surveys have had low participation in the past, so I will also be going out to the community to gather student input directly from our students. Another way to garner student input for the changes I will be proposing to ASI, is to visit ICCs and use public comment to introduce myself. I will be tabling and attending club meetings to speak to students. As I mentioned in my previous speech, I will also be visiting the Irvine campus to talk to students and bring their feedback back to the board.

**3. The issue of accountability of student leaders has been discussed recently. How do you think ASI should address this issue?**

As I'm checking in with our community, I will check in about our student leaders. I will take student feedback back to the board. I will gather data, report it to the Chair, and have the chair come up with a solution. It is important to encourage students to call out their representatives. We have attended conferences at the expense of the students, our goal should be to encourage student power and for them to become more involved. My goal is to get more students to attend our Board meetings and for them to be more outspoken. Currently, many students have expressed that they feel intimidated in these Board meetings and that is why they do not attend. If they feel they can hold their leaders accountable, they are more likely to become involved.

**4. If you were to write a resolution that supported an increase in sustainability efforts around the CSUF campus, what are three key details that you think should be provided within the resolution? Why?**

If I were to write a resolution that supported an increase in sustainability efforts around the CSUF campus, I would include the following three key details; organizing town halls, invest into research in the same manner we invest into athletics, and advance ethnic and gender queer settings. Whether sustainability efforts are for DSS, Housing, Basic Needs, etc. it is important to organize town halls and garner student feedback.

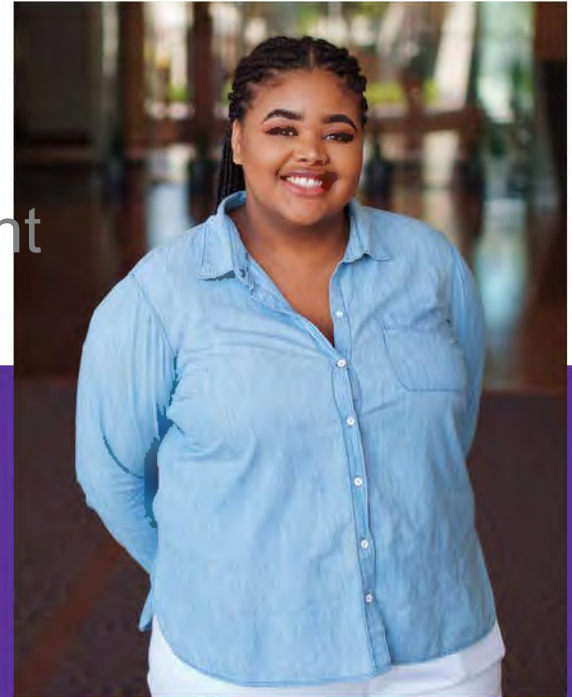

**What do you believe is the role of ASI on our campus and how does that role relate to this position? \***

I believe that ASI's role is to bring students together in a way that makes CSUF feel more personal. ASI provides students with the ability to gain work experience, develop school spirit, and participate in multiple extracurricular activities. I also believe that a large role of ASI is providing students unique experience they could otherwise not have without the structure of ASI. This can be seen through the multiple funded councils underneath ASI such as the Black Student Union and the Association for Inter-Cultural Awareness. These councils provide support and a sense of community among marginalized students such as myself. The role of the Board of Directors is to help oversee organizations like these and represent the diverse students that attend CSUF. Because each member represents a different college, it is the responsibility of the representatives to accurately work on the behalf of their peers. This role is important in making sure ASI is fairly supporting all students at CSUF.



**Tell us about any relevant past involvement or work experience that you have and how it will help you as a Director for your college. \***

When I was a freshman, the first club I joined was ASI's Street Team. Through that organization I was able to volunteer for multiple events around campus. In this club, I learned about CSUF's annual Spring Concert. I applied for and obtained the position of a Lead Volunteer for CSUF's Spring Concert 2016. Through these two positions I was able to get a glimpse of how ASI functioned as a student government. Other positions I have held include being the Leadership Development Coordinator of the Black Student Union during the 2016–2017 school year. During the 2017–2018 school year I was president of Sistertalk which is an organization that acts as a safe space for women of color on campus to discuss shared life experiences and ways to succeed academically as well as professionally. Since the year 2015, I have worked for two child care facilities in Los Angeles.
